Thanks for helping us out with the development plan. Here is what we think we can do now—for each incremental well TIL'd in 2025 above the current 6 permitted, we would [REDACTED] Marathon, for [REDACTED] [REDACTED] NMA from Tumbler (i.e., if MRO were to TIL all 24 wells in 2025, they would [REDACTED] [REDACTED] NMA). We would also [REDACTED] NMA for every well drilled in 2026. Right now, our asset team is evaluating how COP will most effectively develop this unit, so can't speak to exact well placement in individual units just yet, but we will re-apply for pooling.

As to the Madera wells, we're aware of our options to maintain the Federal and State leases in this unit. Hi Caroline,

Thank you for confirming that COP recognizes Madera 24 Federal #1 as the sole well holding the federal lease in the Goliath unit. Given this fact, the well's current production, and COP's ownership of 686 acres in the core undeveloped Stateline unit, we hope COP is working diligently to spud new wells in the immediate future.

Stronghold, through Tumbler Operating Partners, owns 142 acres in Goliath and is exploring all possible avenues to expedite development. We are eager to remain a trusted partner with COP, but we need more clarity regarding COP's plans for this unit. Our primary concerns are as follows:

1. Declining Production

- Madera 24 Federal #1 produced 51 BO in December. This fell by 24% to 38 BO in January. Based on current rates, February is on track for a further 55% drop to 17 BO.
- Please see the attached PDS export (covering 1/1/24 to present) for production data prior to this.

2. Clarification on PDS Data

- **Surface Equipment:** From 1/22/25 through 2/9/25, the Downtime Reason (Column P) was noted as "Gas Lift Surface Equipment." On 2/10/25, it changed to "Separator." Could you clarify what is happening at the surface?
- **Downtime Hours vs. Reported Production:** On 1/29/25 and 2/4/25, downtime (Column O) was listed at 24 hours, yet there was reported oil production of 2.1 and 2.5 BO, respectively. How can the well produce if downtime is listed at 24 hours? How is the well currently operated and how is production being recorded?
- **Production Gaps:** Since 1/21/25 (over 21 days), the well has only produced on five of those days, yielding a total of 14 BO. Is there a downhole issue?

3. Concerns About Future Workovers

- MRO attempted a workover on this well in October following a proposal from Stronghold. Another successful workover seems uncertain.
- Given the well's current condition and associated risks, relying solely on Madera 24 Fed #1 to maintain the lease—rather than promptly drilling new wells—appears highly risky.

Please let me know your availability to discuss Goliath. Would you also be open to connecting me with a production engineer to review the situation at Madera 24 Fed #1?

As your conversations with Caroline and Juan confirm, Conocophillips recognizes the importance of this project and it is absolutely in plan for our development of this area. While COP acquired Marathon and their assets, we did not acquire their drill schedule. All their projects are being married with our legacy projects in the most efficient way possible given our capital guidance. An understanding of that situation and the fact we have such a large portfolio of New Mexico inventory competing for capital is needed to explain why COP is not developing the project this year. You correctly point out that the pooling orders will expire in May, that is unfortunately unavoidable as they have been already previously extended by Marathon. What is not expiring this year is the permits and based on our planning discussions with our development team, COP plans to develop within the timeframe of the permit term with a tentative earliest estimate of drilling in 2026. This is clearly not what you are wanting to hear but is just the consequence of the Marathon and COP acquisition in season of capital focus.

You allude to re-evaluations, opportunities for you and other groups. I'm not sure what you are specifically trying to tell me and Caroline or if you are trying to pressure us into a discussion without a specific substantive goal.
