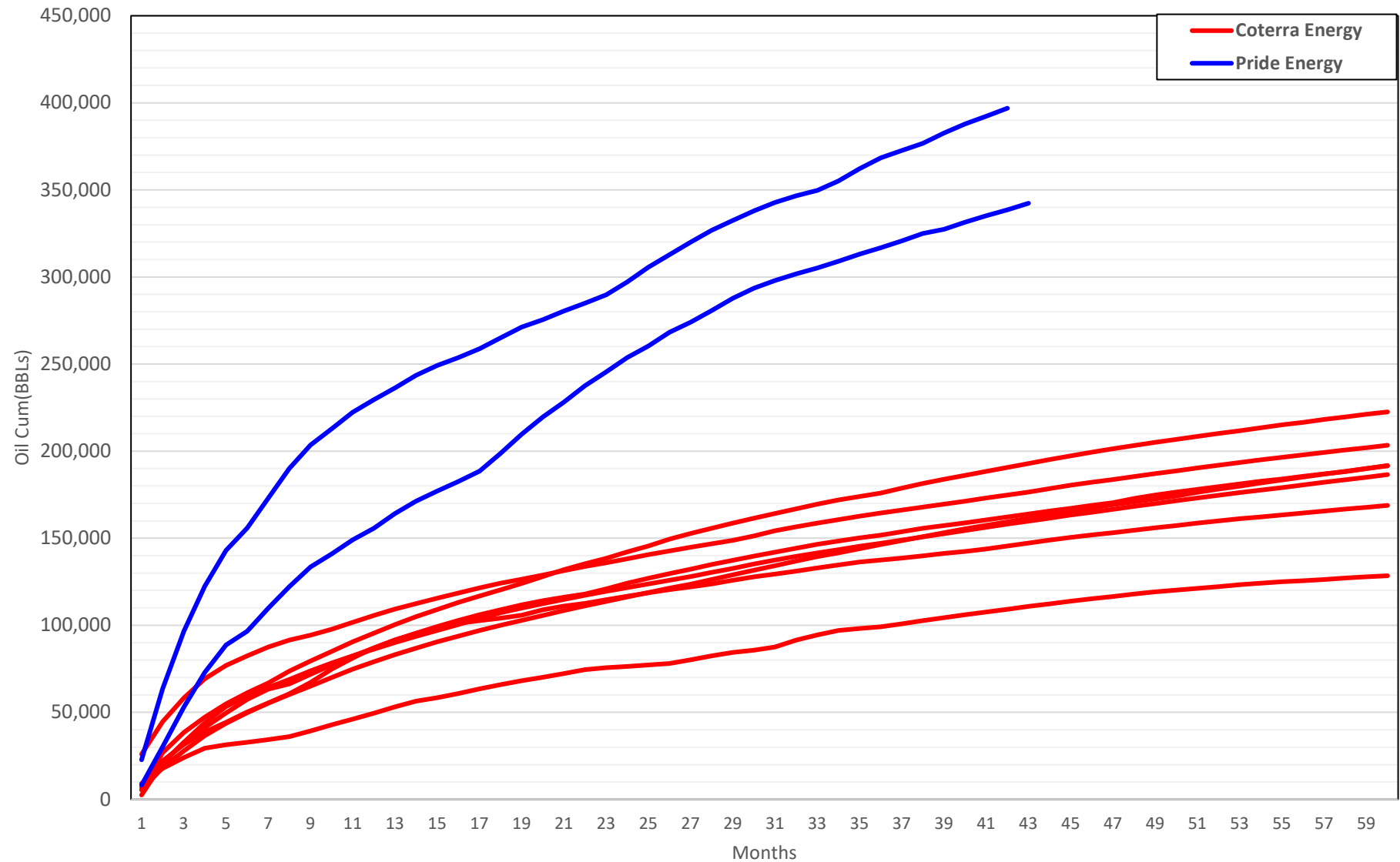

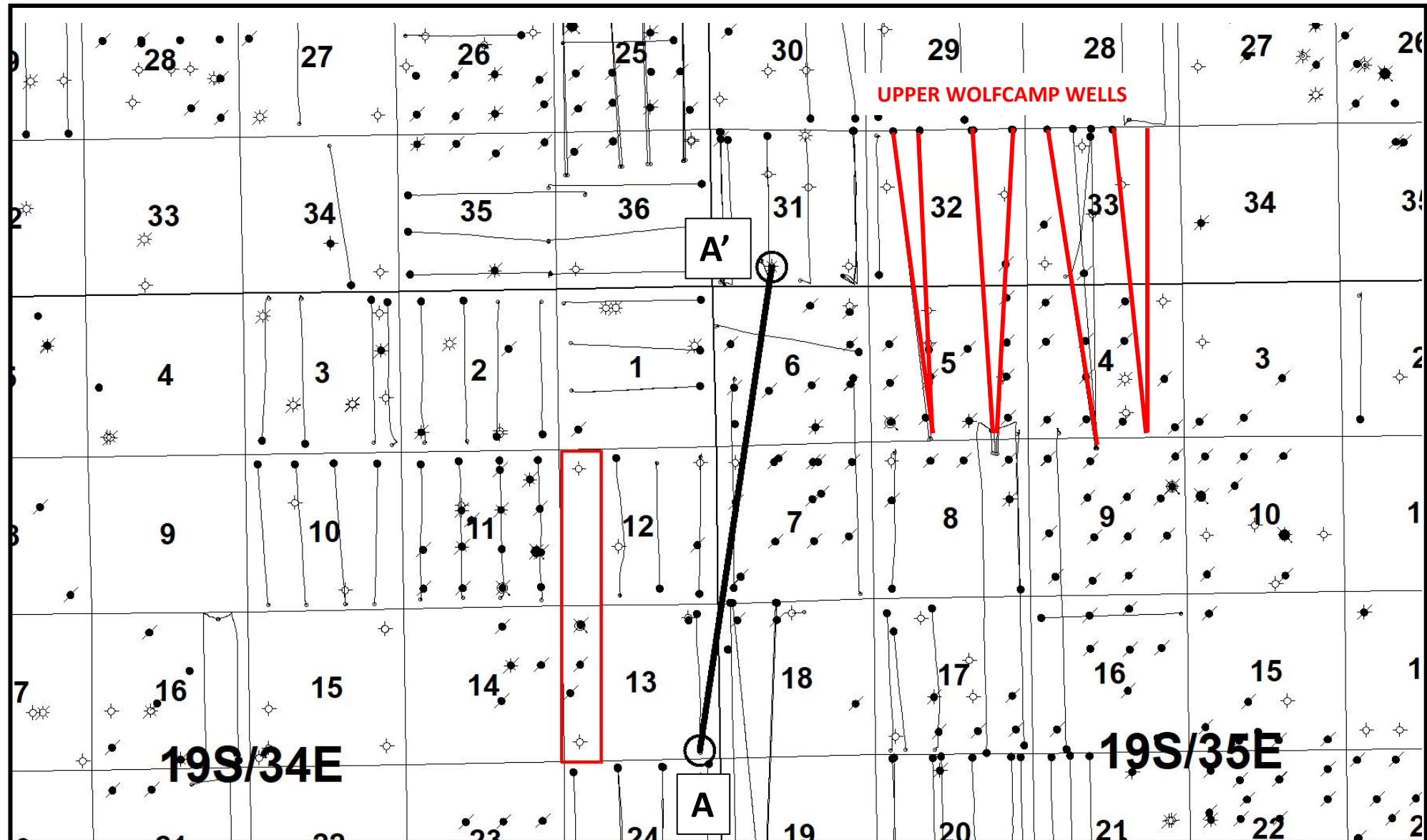

Oil Cumulative - 3rd Bone Spring

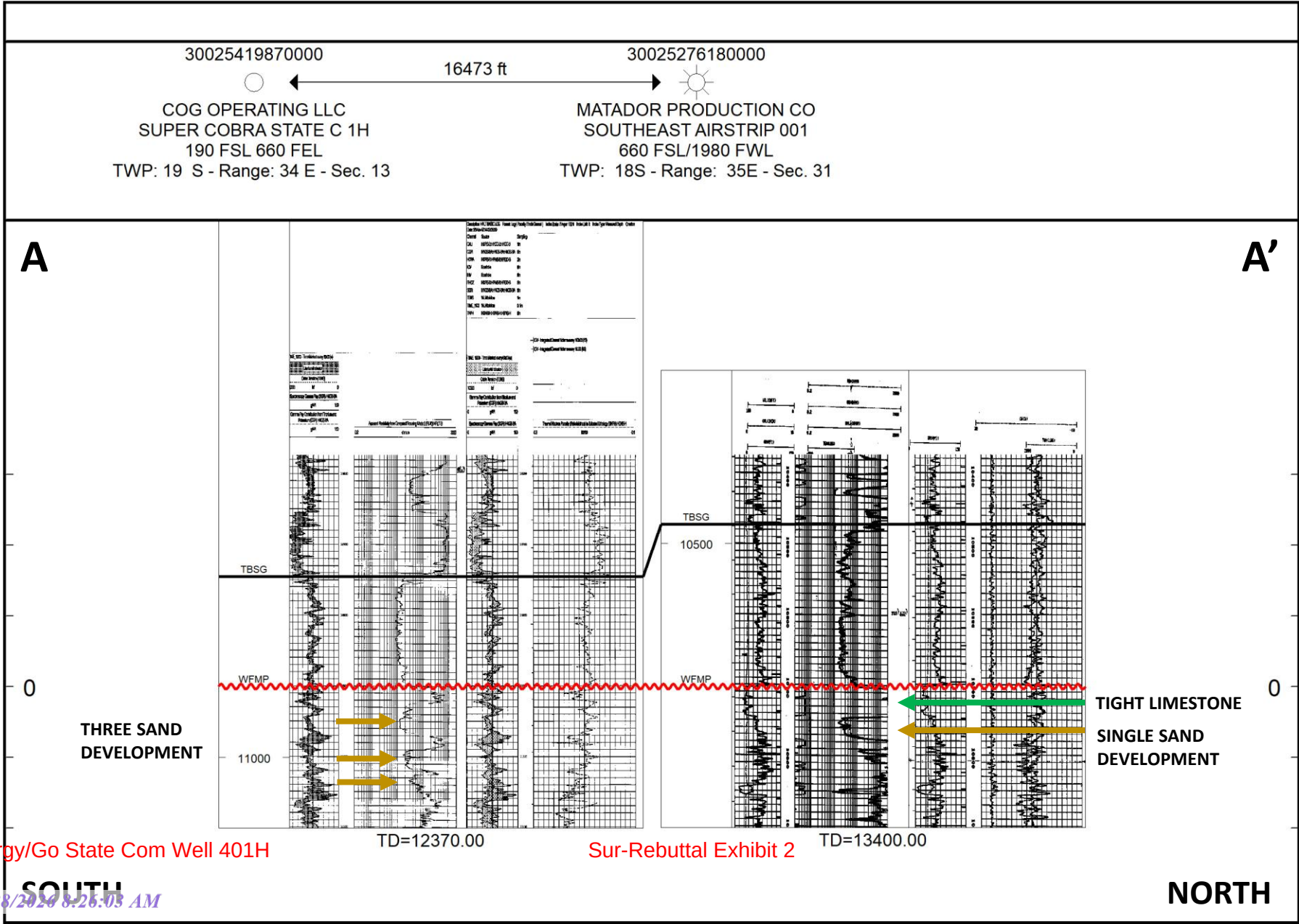


SOUTH TO NORTH CROSS SECTION REFERENCE MAP
