APPLICATION

Marathon Oil Permian, LLC (“Marathon” or “Applicant”), through its undersigned attorneys, hereby files this application with the Oil Conservation Division to amend Pooling Order R-23223, as amended, to add an additional interest owner to the pooling order. In support of its application, Marathon states:

1. On May 22, 2024 the Division issued Order No. R-23223 (the “Order”) in Case No. 24150, pooling the uncommitted interest owners in the Bone Spring formation (Cass Draw; Bone Spring [10380]) underlying the S/2 of Sections 28 and 29, Township 22 South, Range 27 East, NMPM, Eddy County, New Mexico (the “Unit”), and dedicated this standard 640-acre, more or less, horizontal well spacing unit to the proposed initial **Magellan BS Fee 501H** (API No. 30-015-57453) and **Magellan BS Fee 502H** (API No. 30-015-PENDING). Marathon is the designated operator of the Unit under the Order.
2. On June 18, 2025, the Division issued Order No. R-23223-A, extending the period to drill the wells until May 22, 2026.
3. Applicant has discovered an additional interest owner in the pooled acreage that was not subject to the pooling proceedings giving rise to Order R-23223.

4. Applicant has sought and been unable to obtain voluntary agreement for the development of these lands from this additional interest owner.

WHEREFORE, Applicant requests that this application be set for hearing before an Examiner of the Oil Conservation Division on March 5, 2026, and, after notice and hearing as required by law, the Division enter an order pooling this additional interest owner under the terms of Order R-23223.
