BY MR. WORDEN: The purpose of this hearing is to consider the request of J. P. Cusask for a closer spacing than is provided by the rules of the Commission.

The reupon,

J. P. CUSACK and B. A. BOWERS were called and duly sworn by the Land Commissioner.

Mr. J. P. Cusack testified as follows:

EXAMINATION BY MR. SETH.

Question: Your name is J. P. Cusack?

Answer: Yes.

- Q. You are an oil operator, at Hobbs?
- A. Yes.
- Q. Do you hold the lease on the $E_2^{\frac{1}{2}}SE_1^{\frac{1}{2}}$ of Section 34, Township 18 South, Range 38 East, in Lea County?
- A. I do.
- Q. Mr. Cusack, is that in the town of Hobbs?
- A. It is.

- Q. Is it in the part of the town of Hobbs, at least in the part of the town that is built up?
- A. It is.
- Q. Now, I hand you the applicant's Exhibit 1, entitled "Map of Hobbs," and ask you if that area enclosed with a red line represents the E2SE2 of Section 34?
- A. It does.

(Map introduced in evidence, marked "Exhibit 1".)

- Q. Is the town of Hobbs divided into lots, as shown on this Exhibit?
- A. It is.
- Q. Mr. Cusack, the place where you desire to drill the well that this hearing is about, I take it it is in Lot 24 of Block 25, is that correct?
- A. That is correct.
- Q. What is the distance of that location from the West line of the $\mathbb{E}_2^1 \mathbb{S} \mathbb{E}_4^1$ of Section 34?
- A. Approximately 130 feet.
- Q. And what distance is it from the North line of your lease?
- A. Approximately 1000 feet.
- Q. Mr. Cusack, are you interested in the lease lying immediately West of your lease?
- A. I am not.
- Q. Are you not interested in the WasE of Section 34?
- A. I am not.
- Q. What company is interested in this lease?
- A. The Samedan, who are partners of mine in other leases.
- Q. And their spacing has been on the basis of 330 feet from the West line of the eighty, and 660 feet from the North line, and have drilled wells with such spacing?
- A. Yes.
- Q. And if you followed that system on your lease, that is, the E2SE2 of Section 34, where would it put the well, with reference to buildings, or schools?
- A. On the school property and immediately adjacent to the school building proper.
- Q. Now, this smaller area embraces parts of Blocks 96, 3 and 26. What does that represent?
- A. School property.
- Q. Are they building schools on that property?
- A. The school is built, and there is an ethletic field also on the property.

- Q. And to drill the well at the 330-660 spacing would put it right in the middle of the school property?
- A. It would put it where the school building is now located.
- Q. Yes, and if you moved it a short distance, it would still be on the school property.
- A. Yes, it would still be on school property.
- Q. Now, are there any producing wells east of your lease there, at all?
- A. No, no producing wells.
- Q. Is is regarded as pretty nearly on the edge of the production area, this lease?
- A. Yes, it is definitely on the edge of production. There is a dry hole to the East, and a very severe dip to the East.
- Q. The Samedan, which has the W_2^1 of this quarter section, have they indicated to you that they have no objection to this permit being granted?
- A. Yes, they have.
- Q. Is the Empire also interested?
- A. The Empire has a small operating agreement with the Sameden, in the West half.
- Q. Has the Empire wired you that they have no objection to the proposed spacing?
- A. Yes, they have wired me that they have no objections, considering the circumstances.
- Q. Mr. Cusack, do you know the royalty interest under the East half and the West half of the Southeast quarter of this section?
- A. T do.
- Q. Are they virtually all held by the same person?
- A. Virtually, yes.
- Q. Is that all part of the Turner homestead?
- A. It is.
- Q. Both eighty-acres?
- A. They are.
- Q. You have been in the oil business at Hobbs, in that vicinity for a good many years, haven't you?
- A. Approximately eight years.
- Q. And you are familiar with conditions there?
- A. I am.
- Q. In your opinion, would the granting of permission to drill a well at the place for which you have made application, in any manner injure the royalty interests or leasehold interests in that vicinity?

- A. In my opinion, it would not.
- Q. What is your opinion as to its affect on the ultimate recovery of the oil in the $\mathbb{E}_{\mathbb{R}}^{\frac{1}{2}}S\mathbb{E}_{\mathbb{T}}^{\frac{1}{2}}$ of the eighty, on which you have a lease?
- A. Do you mean as to affecting the West half?
- Q. No, I mean its affect on you. Would it enable you to get more than your fair share of the oil?
- A. I would say not, for the reason that the water drive is coming from the West and South, and there is no water on the East side in this immediate area at present.
- Q. None has shown up at the present time?
- A. No.
- Q. Where is that dry hole you mentioned located?
- A. That dry hole is located approximately in the Northwest quarter of the Southwest quarter of Section 35.
- Q. In the Hobbs townsite?
- A. Yes.
- Q. Has any water shown up?
- A. No, not in the producing horizon. It is some four or five hundred feet below.
- Q. That is all.

UPON EXAMINATION BY MR. SETH, Mr. B. A. Bowers testified as follows:

- Q. Mr. Bowers, you have been producing oil at Hobbs for several years?
- A. That is right.
- Q. And you are familiar with the conditions in that locality?
- A. That is right.
- Q. And in the locality of this lease of Mr. Cusack, on the $E_{0}^{1}SE_{0}^{1}$ of Section 34?
- A. Yes.
- Q. You have heard the testimony of Mr. Cusack with reference to the location of the school building and grounds, as covering the point where the well would be located ordinarily.
- A. I have.
- Q. And that is correct?
- A. Yes, that is correct.
- Q. Are you familiar, generally, with the royalty interests covering the entire Southeast quarter?

- A. Not to the extent that Mr. Cusack has stated that he is, but in general, I will concur with his statement.
- Q. It is all based on the old Turner horestead?
- A. Yes.
- Q. And the town lots were sold with reservation of minerals?
- A. That is correct.
- Q. Is that pert of Hobbs, where the school grounds are located, as shown on this Exhibit I, built up; that is, are there other buildings around the school?
- A. Yes, that is quite settled up around there.
- Q. And this location that Mr. Cusack is seeking, is that approximately the closest he can get?
- A. That is the most practical location to make, in view of fairness to the school and the present occupants of the property.
- MR. ANDREAS: How close to any building is this proposed location?
- A. There is a house immediately across the Street to the East, and in the adjoining block, it is well filled up with buildings.
- MR. ANDREAS: How about North and South?
- A. There is a Street on the North, Carlsbad Avenue, which is the Main street through Hobbs, and across the street, South, there is a considerable number of buildings in that block.
- Q. There are less buildings in this block in which the tentative location of the well is shown then in any other block in the immediate vicinity?
- A. Yes.
- Q. In your opinion, considering the surface occupancy, is this the best location?
- A. Ves.
- . In your opinion, would the locating of the well there be unfair to the adjoining mineral rights?
- A. I will answer and make my statement in this way: were I the royalty owner in the Samedan lease immediately adjoining it on the West, I would have no hesitancy at all in agreeing to Mr. Cusack's drilling the well on the location that he requests.
- Q. Do you believe this spacing unfair in the sense that Mr. Cusack may be able to get more than his fair share of oil from the lease?
- A. I do not.
- . And how about the ultimate recovery of oil from this well. Do you think he will get a fair recovery from this location?
- A. I believe that he will, because of the fact that, as stated by him, no water drive comes from the East, both from an engineering and a geological standpoint, and it is not probable that there will be. It is more probable that the water will come across

the structure from the West, it seems at present, and not from the East.

- C. Did the school board object to the regular location?
- A. Yes. I have a very close contact with the school board, and am interested in all their work, although I am not a member of the Board, and they do object to the location with the regular spacing, if it can possibly be done in any other way.
- Q. Are they erecting new school buildings?
- A. They have erected one and they intend to build in several on the present grounds.
- MR. CUSACK: In this respect, I called Mr. Staley, who is President of the School Board and also proration umpire at Hobbs, and asked him if they would approve this location, and he said definitely no, and when he said that, I started in to find out if there wasn't some other location available. They objected for two reasons, the safety factor, for one thing, and the space.
- Q. While this may be beyond the jurisdiction of the Commission in a sense, you have wholly cooperated with the school board in this new location which you seek?
- A. Yes.
- C. And the proration umpire at Hobbs is also chairman of the school board?
- A. Yes.
- MR. WORDEN: There is no objection from any member of the school board as to this new location?
- A. No, there is none whatsoever. They are perfectly satisfied.
- MR. WORDEN: And they feel that it is a safe distance and would not be likely to injure any of the children?
- A. That is right. They feel that this location could not possibly injure them in any way.

- Q. Is the town of Hobbs divided into lots, as shown on this Exhibit?
- A. It is.
- Q. Mr. Cusack, the place where you desire to drill the well that this hearing is about, I take it it is in Lot 24 of Block 25, is that correct?
- A. That is correct.
- Q. What is the distance of that location from the West line of the RiSE of Section 34?
- A. Approximately 130 feet.
- Q. And what distance is it from the North line of your lease?
- A. Approximately 1000 feet.
- Q. Mr. Cusack, are you interested in the lease lying immediately West of your lease?
- A. I am not.
- Q. Are you not interested in the WaSE of Section 34?
- A. I am not.
- Q. What company is interested in this lease?
- A. The Samedan, who are partners of mine in other leases.
- Q. And their spacing has been on the basis of 330 feet from the West line of the eighty, and 660 feet from the North line, and have drilled wells with such spacing?
- A. Yes.
- Q. And if you followed that system on your lease, that is, the EiSE2 of Section 34, where would it put the well, with reference to buildings, or schools?
- A. On the school property and immediately adjacent to the school building proper.
- Q. Now, this smaller area embraces parts of Blocks 96, 3 and 26. What does that represent?
- A. School property.
- Q. Are they building schools on that property?
- A. The school is built, and there is an athletic field also on the property.

- Q. And to drill the well at the 350-660 spacing would put it right in the middle of the school property?
- A. It would put it where the school building is now located.
- Q. Yes, and if you moved it a short distance, it would still be on the school property.
- A. Yes, it would still be on school property.
- Q. Now, are there any producing wells east of your lease there, at all?
- A. No, no producing wells.
- Q. Is is regarded as pretty nearly on the edge of the production area, this lease?
- A. Yes, it is definitely on the edge of production. There is a dry hole to the East, and a very severe dip to the East.
- Q. The Samedan, which has the Wo of this quarter section, have they indicated to you that they have no objection to this permit being granted?
- A. Yes, they have.
- Q. Is the Empire also interested?
- A. The Empire has a small operating agreement with the Samedan, in the West half.
- Q. Has the Empire wired you that they have no objection to the proposed spacing?
- A. Yes, they have wired me that they have no objections, considering the circumstances.
- Q. Mr. Cusack, do you know the royalty interest under the East half and the West half of the Southeast quarter of this section?
- A. I do.
- Q. Are they virtually all held by the same person?
- A. Virtually, yes.
- Q. Is that all part of the Turner homestead?
- A. It is.
- Q. Both eighty-acres?
- A They are.
- Q. You have been in the oil business at Hobbs, in that vicinity for a good many years, haven't jou?
- A. Approximately eight years.
- Q. And you are familiar with conditions there?
- A. I am.
- Q. In your orinion, would the granting of permission to drill a well at the place for which you have made application, in any manner injure the royalty interests or leasthold interests in that vicinity?

- A. In my opinion, it would not.
- Q. What is your opinion as to its affect on the ultimate recovery of the oil in the EgSE of the eighty, on which you have a lease?
- A. Do you mean as to affecting the West half?
- Q. No, I mean its effect on you. Would it enable you to get more than your fair share of the oil?
- A. I would say not, for the reason that the water drive is coming from the West and South, and there is no water on the East side in this immediate area at present.
- Q. None has shown up at the present time?
- A. No.
- Q. Where is that dry hole you mentioned located?
- A. That dry hole is located approximately in the Northwest quarter of the Southwest quarter of Section 35.
- Q. In the Hobbs townsite?
- A. Yes.
- Q: Has any water shown up?
- A. No, not in the producing horizon. It is some four or five hundred feet below.
- Q. That is all.

UPON EXAMINATION BY MR. SETH, Mr. B. A. Bowers testified as follows:

- Q. Mr. Bowers, you have been producing oil at Hobbs for several years?
- A. That is right.
- Q. And you are familiar with the conditions in that locality?
- A. That is right.
- Q. And in the locality of this lease of Mr. Cusack, on the EdSEd of Section 34?
- A. Yes.
- Q. You have heard the testimony of Mr. Cusack with reference to the location of the school building and grounds, as covering the point where the well would be located ordinarily.
- A. I have.
- Q. And that is correct?
- A. Yes, that is correct.
- Q. Are you familiar, generally, with the royalty interests covering the entire Southeast quarter?

- A. Not to the extent that Mr. Cusack has stated that he is, but in general, I will concur with his statement.
- Q. It is all based on the old Turner homestead?
- A. Yes.
- Q. And the town lots were sold with reservation of minerals?
- A. That is correct.
- Q. Is that pert of Hobbs, where the school grounds are located, as shown on this Exhibit 1, built up; that is, are there other buildings around the school?
- A. Yes, that is quite settled up around there.
- Q. And this location that Mr. Cuback is seeking, is that approximately the closest he can get?
- A. That is the most practical location to make, in view of fairness to the school and the present occupants of the property.
- MR. ANDREAS: How close to any building is this proposed location?
- A. There is a house immediately across the Street to the East, and in the adjoining block, it is well filled up with buildings.
- MR. ANDREAS: How about North and South?
- A. There is a Street on the Morth, Carlsbad Avenue, which is the Main street through Hobbs, and across the street, South, there is a considerable number of buildings in that block.
- Q. There are less buildings in this block in which the tentative location of the well is shown than in any other block in the immediate vicinity?
- A. Yes.
- Q. In your opinion, considering the surface occupancy, is this the best location?
- A. Yes.
- Q. In your opinion, would the locating of the well there be unfair to the adjoining mineral rights?
- A. I will answer and make my statement in this way: were I the royalty owner in the Samedan lease immediately adjoining it on the West, I would have no hesitancy at all in agreeing to Mr. Cusack's drilling the well on the location that he requests.
- Q. Do you believe this spacing unfair in the sense that Mr. Cusack may be able to get more than his fair share of oil from the lesse?
- A. I do not.
- 6. And how about the ultimate recovery of oil from this well. Do you think he will get a fair recovery from this location?
- A. I believe that he will, because of the fact that, as stated by him, no water drive comes from the East, both from an engineering and a geological standpoint, and it is not probable that there will be. It is more probable that the water will come across

the structure from the West, it seems at present, and not from the East.

- Q. Did the school board object to the regular location?
- A. Yes. I have a very close contact with the school board, and am interested in all their work, although I am not a member of the Board, and they do object to the location with the regular spacing, if it can possibly be done in any other way.
- Q. Are they erecting new school buildings?
- A. They have erected one and they intend to build in several on the present grounds.
- MR. CUSACK: In this respect, I called Mr. Steley, who is President of the School Board and also proration umpire at Hobbs, and asked him if they would approve this location, and he said definitely no, and when he said that, I started in to find out if there wasn't some other location available. They objected for two reasons, the safety factor, for one thing, and the space.
- Q. While this may be beyond the jurisdiction of the Commission in a sense, you have wholly cooperated with the school board in this new location which you seek?
- A. Yes.
- Q. And the proration umpire at Hobbs is also chairman of the school board?
- A. Yes.
- MR. WORDEN: There is no objection from any member of the school board as to this new location?
- A. No, there is none whatsoever. They are perfectly satisfied.
- MR. WORDEN: And they feel that it is a safe distance and would not be likely to injure any of the children?
- A. That is right. They feel that this location could not possibly injure them in any way.

That is all.

There being no further business to come before the hearing, the hearing adjourned.


