MR. HATCH: Northwestern nomenclature case calling for an order for the creation and extension of certain pools in Rio Arriba, Sandoval and San Juan Counties, New Mexico.

(Witness sworn.)

A. R. KENDRICK

called as a witness, having been first duly sworn, was examined and testified as follows:

DIRECT EXAMINATION

BY MR. HATCH:

Q Would you state your name and position for the record?

A A. R. Kendrick, petroleum engineer for the Oil Conservation Commission.

Q Are you prepared to make recommendations to the Examiner concerning the creation and extension of certain pools in Rio Arriba and Sandoval and San Juan Counties, New Mexico?

A Yes, sir.

Q Are your recommendations prepared in the form of an exhibit?

A Yes.

Q Would that be Exhibit 1 in Case 4229, paragraphs A

through L?

A Yes.

(Whereupon, Exhibit No. 1
was marked for identification.)

Q Would you refer to paragraphs A through L of your Exhibit 1 and to the docket and point out any corrections that need to be made?

A The only difference that occurs is in paragraph A, wherein the docket reads that the name of the pool would be the Cereza Mesa-Gallup Pool, and I represent that the pool be named the BS Mesa-Gallup Pool. I agree the name is not too dignified, but I didn't write that.

Q The rest of the docket is correct?

A Yes. And identical.

Q Do you recommend that the pools in paragraphs A through L be extended and created as shown by your exhibit and on the docket and as you have changed?

A Yes.

Q Was Exhibit 1 prepared under your supervision?

A Yes.

MR. HATCH: I would like to introduce Exhibit 1.

MR. PORTER: If no objections, the exhibit will be admitted.

offered and admitted in evidence.)

MR. PORTER: In regard to this change, Mr. Kendrick, that is the local name for this area?

THE WITNESS: It's the name on the U.S.G.S. quadrangles.

ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 a.m. on October 15, 1969, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 22nd day of October, 1969, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That there is need for the creation of a new gas pool in Rio Arriba County, New Mexico, for the production of gas from the Gallup formation, said pool to bear the designation of BS Mesa-Gallup Pool. Said BS Mesa-Gallup Pool was discovered by the Consolidated Oil and Gas, Incorporated Hoyt Well No. 1, located in Unit H of Section 5, Township 26 North, Range 4 West, NMPM. It was completed in the Gallup formation on January 19, 1964. The top of the perforations is at 7772 feet.

(3) That there is need for the creation of a new gas pool in Rio Arriba County, New Mexico, for the production of gas from

the Gallup formation, said pool to bear the designation of Wild Horse-Gallup Pool. Said Wild Horse-Gallup Pool was discovered by Southern Union Production Company Jicarilla E Well No. 6, located in Unit B of Section 21, Township 26 North, Range 4 West, NMPM. It was completed in the Gallup formation on January 6, 1957. The top of the perforations is at 7140 feet.

(4) That there is need for certain extensions to the Gavilan-Pictured Cliffs Pool and the Otero-Chacra Pool, both in Rio Arriba County, New Mexico, the Aztec-Pictured Cliffs Pool, the Blanco-Pictured Cliffs Pool, the Fulcher Kutz-Pictured Cliffs Pool, the Mesa-Gallup Oil Pool, and the Hogback-Dakota Oil Pool, all in San Juan County, New Mexico, the Blanco-Mesaverde Pool in Rio Arriba and San Juan Counties, and the Ballard-Pictured Cliffs Pool and the South Blanco-Pictured Cliffs Pool, both in Rio Arriba, Sandoval, and San Juan Counties, New Mexico.



IT IS FURTHER ORDERED:

(1) That, pursuant to Section 65-3-14.5, NMSA 1953, contained in Chapter 271, Laws of 1969, any well which, by virtue of any of the above pool extensions, is subject to pool rules providing for spacing or proration units larger than the one which is presently dedicated thereto, shall have 60 days from the effective date of this order in which to file new Forms C-102 dedicating a standard unit for the pool to said well, or to obtain a non-standard unit approved by the Commission. Pending such compliance, the well shall receive a maximum allowable in the same proportion to a standard allowable for the pool that the acreage dedicated to the well bears to a standard unit for the pool. Failure to file Forms C-102 dedicating a standard unit to the well or to obtain a non-standard unit approved by the Commission within said 60-day period shall subject the well to cancellation of allowable.

(2) That the effective date of this order and all creations and extensions included herein shall be November 1, 1969.

(4) That there is need for certain extensions to the Gavilan - Pictured Cliffs Pool and the Otero - Chacra Pool both in Rio Arriba County, New Mexico, the Aztec - Pictured Cliffs Pool, the Blanco - Pictured Cliffs Pool, the Fulcher Kutz - Pictured Cliffs Pool, the Mesa - Gallup Oil Pool, and the Hogback - Dakota Oil Pool all in San Juan County, New Mexico, the Blanco - Mesaverde Pool in Rio Arriba and San Juan Counties, and the Ballard - Pictured Cliffs Pool and the South Blanco - ~~Blanco~~ Pictured Cliffs Pool both in Rio Arriba, Sandoval and San Juan Counties, New Mexico.
