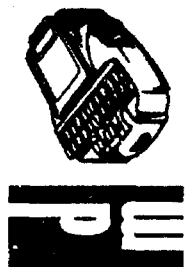

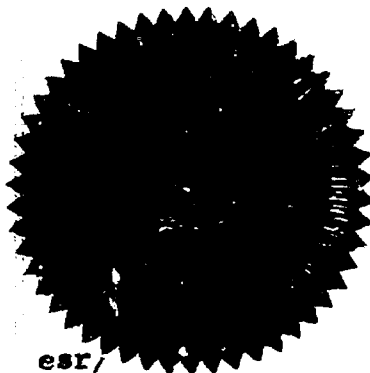

A P P L I C A T I O N

COMES NOW Anne Burnett Windfohr, an individual, d/b/as Windfohr Oil Company, and hereby makes application for an Exception to Commission Order No. R-3221, as amended, said Exception authorizing disposal in an unlined surface pit of water produced from Windfohr Oil Company-Gissler B No. 4 well, located in Unit B (NW $\frac{1}{4}$ NE $\frac{1}{4}$ ) of Section 8, Township 17 South, Range 30 East, N.M.P.M., Eddy County, New Mexico; and, in support of this Application, states:

1. That applicant is the operator of the said Windfohr Oil Company-Gissler B No. 4 well, which is producing from the Grayburg-Jackson (Grayburg-San Andres) pool. Said well is nearing an unprofitable stage of operation, and the expenditure of additional money for an underground disposal facility is not justified.

2. Applicant proposes, if the same be authorized, to dispose of water produced from the said Windfohr Oil Company-Gissler B No. 4 well in an unlined surface pit. Such proposed procedure will require an Exception to Commission Order No. R-3221, as amended, which Order prohibits, subject to minor exceptions, the disposal of produced water in surface pits. Applicant submits that said exception is justified for the following reasons:

(a) That there appear to be no shallow fresh water wells in the vicinity of the said Windfohr Oil Company-Gissler No. 4 well; and

(b) That there appears to be no shallow fresh water in the vicinity of the said Windfohr Oil Company-Gissler B No. 4 well for which a present or reasonably foreseeable beneficial use is or will be made that would be impaired by contamination.


3. That a map of the area outlining the lease and showing the well involved in this application is attached hereto, marked Exhibit "A" and made a part hereof.

4. Recent production tests on the Windfohr Oil Company-Gissler B No. 4 well showed production of 3 BOPD and 15 BWPD.

WHEREFORE, applicant requests a hearing before an examiner, and requests an Order granting an Exception to Commission Order No. R-3221, as amended, as more particularly set out hereinabove.
