



#### APPLICATION

Comes now Merrion Oil & Gas Company, and applies to the Oil Conservation Division of New Mexico for an order pooling all mineral interests underlying the S/2 SE/4 of Section 20, Township 23 North, Range 6 West, NMPM, Sandoval County, New Mexico, for the formation of an oil proration and spacing unit for oil formations from the surface to the base of the Gallup, and in support thereof would show the Commission:

- 1.
