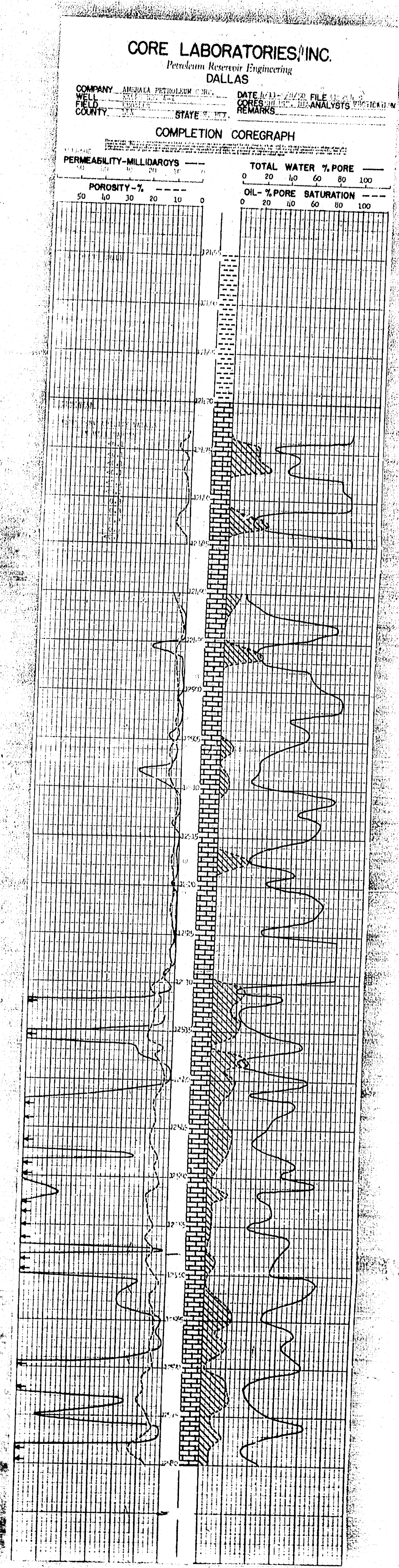
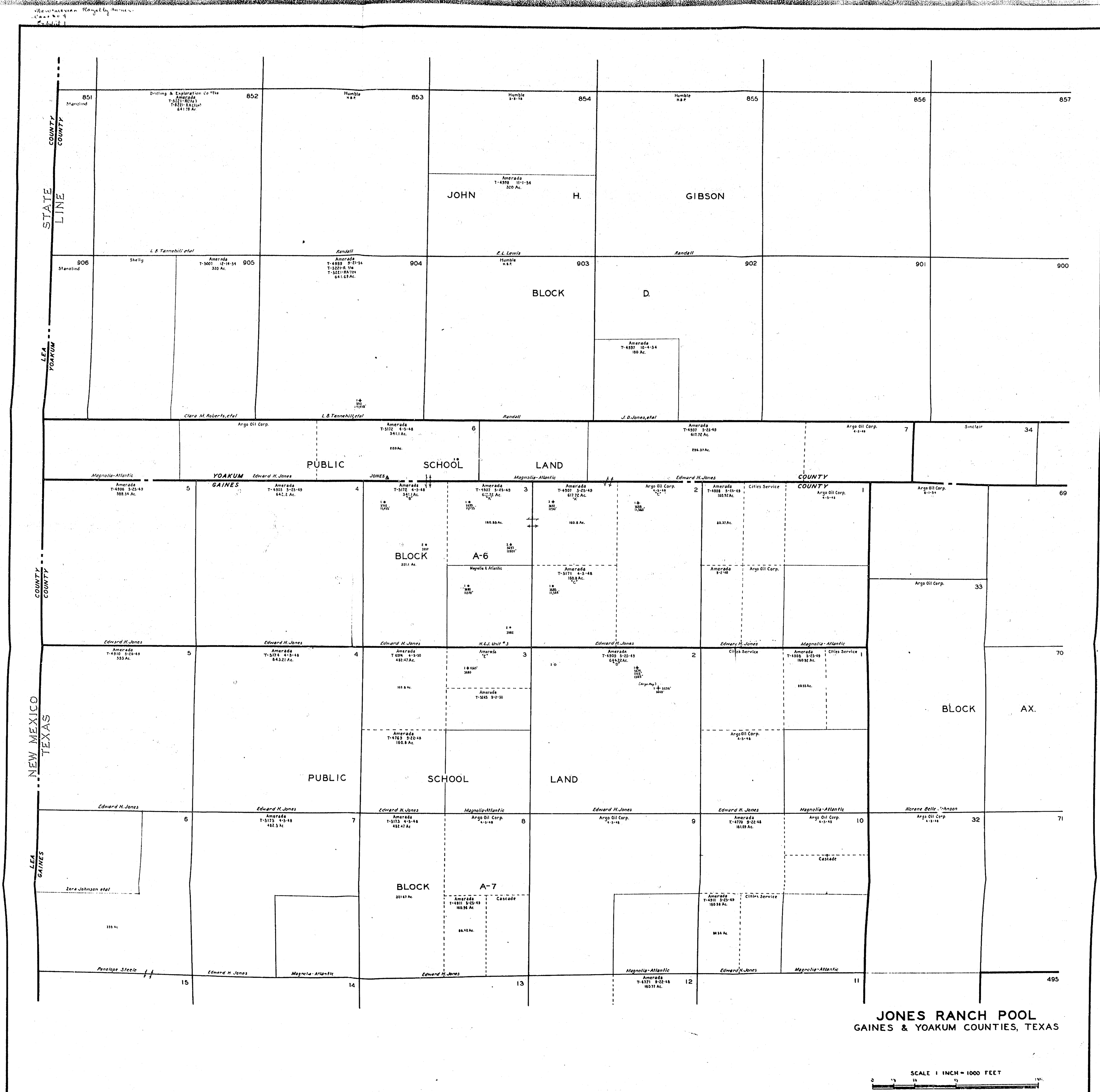

**GAINES & YOAKUM COUNTIES, TEXAS**

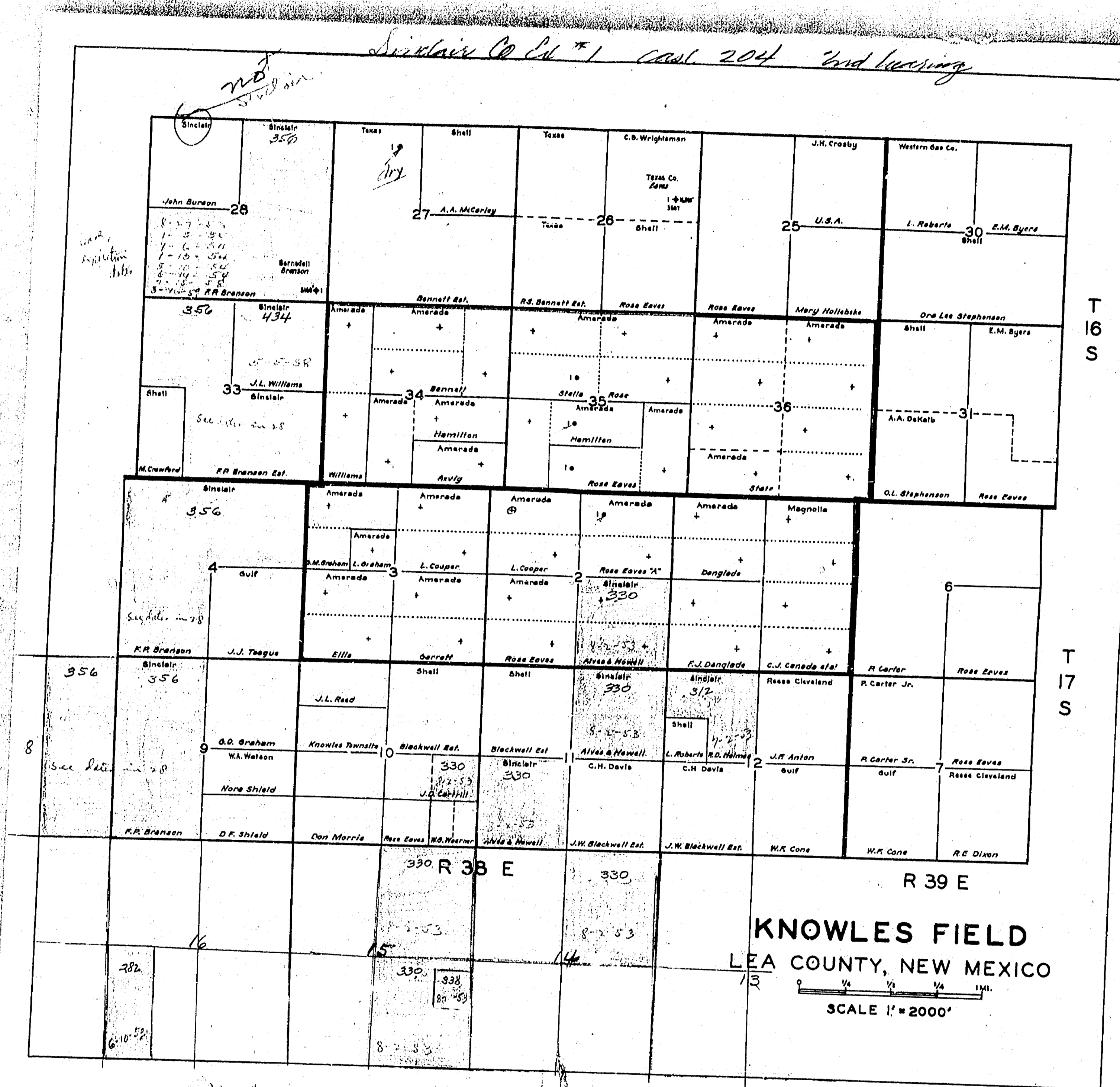
