APPLICATION

Come now Applicants, Gulf Oil Corporation, hereinafter called Gulf, and Western Oil Fields, Inc., hereinafter called Western, and show to the Commission:

- 1. Gulf is the owner and holder of an oil and gas lease dated April 3, 1944, from Amanda E. Sims and her husband, George W. Sims, covering among other lands the S/2 of the SE/4 and the NW/4 of the SE/4 of Section 25, Township 22 South, Range 37 East, N.M.P.M. Lea County, New Mexico, said lease providing for a royalty of 1/8th of 8/8ths on oil and gas.
- 2. Western is the owner and holder of an oil and gas lease dated March 11, 1950, from A.M. Drinkard and others covering among other lands the NE/4 of the SE/4 of said Section 25, said lease providing for a royalty of 3/16ths of 8/8ths on oil and gas.
- 3. Amanda E. Sims is the sole owner of all of the oil and gas royalties provided in said leases.
- 4. As of July 6, 1956, Gulf and western in order to protect their correlative rights and comply with Order R-610 and R-586 of the Commission entered into a gas pooling agreement covering the SE/4 of said Section 25. In said agreement Gulf and Western pooled all of their interests in said tract as to gas to be developed and produced from gas wells within the vertical limits of the Blinebry Gas Pool in order to form a pooled proration unit to be known as Amanda Blinebry Gas Unit No. 1 and said parties likewise pooled all of their interests in said tract as to gas to be developed and produced from gas wells within the vertical limits of Tubb Gas

I Pools in order to form a pooled proration unit to the known as Amanda Tubb Gas Unit No. 1. Said pooled units were each to be operated by Gulf.

- 5. Amanda R. Sims has refused to consent to or ratify the pooling agreement.
- 6. Gulf has a dually completed gas-gas well 1320 feet from the south line and 1320 feet from the east line of said Section 25 from which the unit allowable for each of the above described units can be produced and Western has no gas well in the Blinebry or Tubb Gas Pools on its above described 40-acre tract. Gulf is producing from its said well gas from each of said gas pools on the basis of a nonstandará 120-acre unit.
- 7. Under the pooling agreement the dry gas and associated liquid hydrocarbons produced from said gas pools will be allocated among the present or future owners of leasehold or royalty interests in the proportion that the acreage interest of each bears to the entire acreage in the SE/4 of said Section 25. Western will suffer great economic loss if it is required to drill and complete a well or walls on its 40-acre tract in order to obtain its just and equitable share of the production from the Blinebry and Tubb Gas Pools. The Gulf well above described will efficiently drain all of the gas underlying and properly belonging to the SE/4 of said Section 25 in each of the Blinebry and Tubb Gas Pools, as is found by the Commission in its said Orders R-586 and R-610.
- 8. The royalty interest of Amanda E. Sims will not be adversely affected by the compulsory pooling of all of her royalties in the respective units provided by the pooling agreements.
- 9. In order to protect the correlative rights of the Applicants herein and to avoid the drilling of unnecessary wells, it is necessary that the royalty interests under the above described oil and gas leases be pooled by Commission order.

WHEREFORE APPLICANTS REQUEST that the Commission enter its

order pooling all interests underlying the SE/4 of Section 25,
Township 22 South, Range 37 East, Lea County, New Mexico, within
the vertical limits of the Blinebry Gas Pool and within the vertical
limits of the Tubb Gas Pool.

Dear Randall:

In checking the records on the Western Oil Fields, Inc., Awanda Sims 1-I, we find that our file shows it still to be a dual completion in the Drinkard Oil Pool and Tubb Gas Pool. We have records of the work done in connection with dualling the well on Forms C-103 and C-105 and a C-104 approved by our Hobbs Office on February 3rd, 1954.

Checking further, we find that the well was assigned a gas allowable in the Tubb Poel on February 19, 1954, which allowable was continued through December, 1956, but we are unable to find any record of gas production from the Tubb some during that time. Our well file does not indicate that the Tubb perforations have been squeezed off. We note, however, that it is still being produced as a Drinkard oil well.

We would appreciate it very much if you would check with the local representatives of Western and find out the present status of the well and have them file the necessary forms to bring our file up to date.
