- A Elvis A. Utz, Engineer, New Mexico Oil Conservation Commission.
- Q Mr. Utz, in your official capacity as Engineer for the Oil Conservation Commission of New Mexico, have you had an opportunity to make a study of the creation and extension of certain gas pools and oil pools in San Juan and Rio Arriba Counties, New Mexico?
  - A Yes, I have.
- Q Mr. Utz, do you have any recommendation concerning the creation of a new oil pool for Gallup production in Township 30 North, Range 16 West?
  - A Yes, I have. I recommend that a new pool be created

to be known as the Horseshoe-Gallup Oil Pool as advertised, on the basis of fourteen wells capable of producing from that area. The discovery well was the Arizona Exploration Company No. 1 Horseshoe Canyon B in unit D, Section 3, 30 North, 16 West, which was completed for initial potential of 120 barrels per day, and perforation from 1610 to 1654,

Q What would be the vertical limits of the proposed Gallup-Horseshoe Oil Pool?

A The vertical limits would be as advertised. It would be the Gallup formation.

Q Mr. Utz, do you have any recommendations concerning the extension of the vertical limits of the Otero-Graneros Pool?

A Yes, sir, I do. I recommend that the vertical limits of the Otero-Graneros Gas Pool be extended to include the Dakota formation and the name accordingly be changed to the Otero Graneros-Dakota Gas Pool. I recommend that the horizontal limits of the pool be extended as advertised on the basis of five wells completed and capable of producing from this pool.

A Yes, I do. I recommend that the Aztec-Pictured Cliffs
Gas Pool be extended as advertised on the basis of one well
completed and capable of producing from this pool.

Q Do you have any recommendations concerning the extension

Q Have you any recommendations concerning the extension of the Otero-Chacra Pool?

A I recommend that the Otero-Chacra pool be extended as advertised on the basis of three wells capable of producing from this pool.

Q What are your recommendations concerning the extension of the Bisti-Lower Gallup Oil Pool?

A I recommend that the Bisti-Lower Gallup be extended as advertised on the basis of two wells completed and capable of producing from this pool.

Q Do you have any recommendations concerning the extension of the Verde-Lower Gallup Oil Pool?

A I recommend that the Verde-Lower Gallup Oil Pool be extended as advertised on the basis of one well completed and capable of producing from this pool.
