

- Texaco is the operator of the State of New Mexico "M" Lease containing 160 acres and consisting of the NW/4, Section 1, T-18-S, R-34-E, Lea County, New Mexico.
- State of New Mexico "M" Well No. 5 is located in Unit D of said Section 1.
- The Glorieta zone will be an oil completion through casing perforations 6076'-6094'.
- The Blinebry will be an oil completion through casing perforations 6741'-6843'.
- The Wolfcamp zone will be an oil completion through casing perforations 9938'-9960'.
- All three zones will be produced through parallel strings of 2-7/8" casing cemented in a common well bore.

#### ORDER OF THE COMMISSION

### BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on

November 6, 1963, at Santa Fe, New Mexico, before Rivis A. Uts

Examiner duly appointed by the Oil Conservation Commission of New
Mexico, hereinafter referred to as the "Commission," in accordance with Rule 1214 of the Commission Rules and Regulations.

### FINDS:

- (1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.
- (2) That the applicant, Texaco Inc., seeks authority to complete its State of New Newico "M" Well No. 5, located in Unit D of Section 1, Township 18 South, Range 34 East, HMPM, Lea County, New Mexico, as a triple completion (tubingless) to produce oil from the Vacuum-Glorieta, /Vacuum-Molfcamp, and Vacuum-Blinehry Pools through parallel strings of 2 7/8-inch casing cemented in a common well bore.


