BY THE COMMISSION:

April 14, 1965, at Hobbs, New Mexico, before the Oil
Conservation Commission of New Mexico, hereinafter referred
to as the "Commission."

NOW, on this 21st day of April, 1965, the Commission, a
quorum being present, having considered the testimony presented
and the exhibits received at said hearing, and being fully ad-
vised in the premises,

FINDS:

(1) That due public notice having been given as required

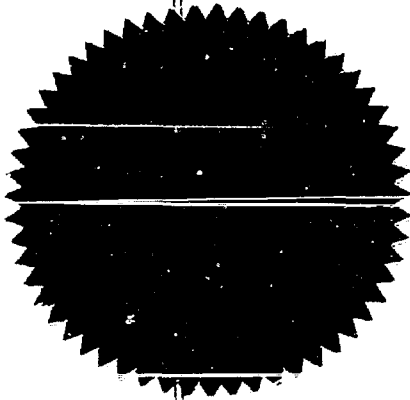

A. R. K E N D R I C K was sworn as a witness, was examined and testified as follows:

DIRECT EXAMINATION

BY MR. DURRETT:

Q Will you please state your name and position for the record.

A A. R. Kendrick, engineer for the Oil Conservation Commission.

Q Where are you located?

A Aztec, New Mexico.

Q Are you prepared to make a recommendation to the Commission this morning concerning extension of certain pools in Rio Arriba, San Juan and Sandoval Counties, New Mexico?

A Yes, sir.

Q Have you prepared this recommendation in the form of an exhibit, Mr. Kendrick?

A Yes, sir.

Q How is that marked?

A Exhibit 1.

Q Will you please refer to Exhibit 1 and to the docket that has been prepared and distributed here today, and point out particularly any additions or corrections.

A There are no changes between the exhibit and the docket.

Q They are identical, and that is your recommendation, is that correct?

A Yes, sir.

Q Do you have a telegram such as I have here?

A I have seen that telegram.

Q And it is within your recommendation?

A I think the acreage covered by the telegram has already been added to the pool. If not, it should be.

MR. PORTER: And you would so recommend?

A Yes, sir.

MR. DURRETT: Was Exhibit 1 prepared by you or under your supervision?

A Yes, sir.

MR. DURRETT: If the Commission please, move the introduction of Exhibit 1. That will conclude my examination of Mr. Kendrick.

MR. PORTER: If there is no objection, the exhibit will be admitted. Are there any questions of the witness? The witness may be excused. If there is nothing further to be

offered in this case, we will take the case under advisement.
