ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 a.m. on January 17, 1968, at Santa Fe, New Mexico, before the Cil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 22nd day of January, 1968, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

FINDS:

- (1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.
- (2) That there is need for the creation of a new oil pool in Lea County, New Mexico, for the production of oil from the San Andres formation, said pool to bear the designation of North Mescalero-San Andres Pool. Said North Mescalero-San Andres Pool was discovered by Cattle Land Oil Company, Atlantic State No. 1, located in Unit G of Section 1, Township 10 South, Range 32 East, NMPM. It was completed in San Andres on September 4, 1967. The top of perforations is 4133 feet.
- (3) That there is need for the re-creation of the East Mason-Delaware Pool in Lea County, New Mexico, inasmuch as the

- (6) That there is need for certain extensions to the Tomtom San Andres Pool in Chaves County, New Mexico, the Baum-Wolfcamp Pool, the South Corbin-Wolfcamp Pool, the Midway-Abo Pool, the North Morton Permo-Pennsylvanian Pool, the Morton-Wolfcamp Pool, and the Vada-Pennsylvanian Pool, all in Lea County, New Mexico, and the Todd-Lower San Andres Pool in Roosevelt County, New Mexico.

JOE D. RAMEY

called as a witness, having been first duly sworn, was examined and testified as follows:

DIRECT EXAMINATION

BY MR. HATCH:

- Q Will you state your name and position for the record?
- A Joe D. Ramey, supervisor of the Commission's District 1.
- Q Are you prepared to make recommendations to the Commission concerning the creation extenstion and contraction of certain pools in Lea, Roosevelt and Chaves Counties, New Mexico?
 - Λ Yes, I am.
- Q Are your recommendations prepared in the form of an exhibit?
 - λ Yes.

- Q What is that exhibit?
- A Southeast Nomenclature Exhibit 1, paragraphs A through L.
- Mould you refer to your exhibit that you just mentioned and to the docket that has been distributed and point out any substantial differences between the two and any corrections that need to be made?
- A I have no corrections to be made. I have additions in paragraphs H and L. Under paragraph H, the addition is in Section 31, the southeast quarter. In paragraph L, I have three additions in Section 20, the southeast quarter, Section 27, the northwest quarter, and Section 28, the north half. The rest of the paragraphs are as advertised on the docket.
- Q And do you recommend to the Commission that the pools be created, extended and contracted as advertised and corrected by the additions in this hearing?
 - A Yes, sir.
- Q Was Southeast Nomenclature Exhibit 1 prepared by you or under your supervision?
 - A Yes, sir, it was.

MR. HATCH: I would like to move the introduction of Southeast Nomenclature Exhibit 1 into evidence at this time.

MR. PORTER: If there are no objections, the exhibit

will be admitted.

(Whereupon, Southeast Nomenclature Exhibit 1 was offered and admitted in evidence.)

MR. PORTER: Any questions of Mr. Ramey? I have one.

CROSS EXAMINATION

BY MR. PORTER:

O Mr. Ramey, did you indicate why you are recreating pools in the East Mason Delaware?

A No, I just never have been able to find out why
the East Mason Delaware was abolished through some mistake
somewhere. It was abolished and added to the North Mason
Delaware Pool but there is evidently separation between the
two pools and it is a factor of allowable. The allowable
for the East Mason is considerably higher than that for the
North Mason.

Q In other words, it creates an inequity as far as people who own wells in the East Mason Delaware.

MP. PORTER: If there are no further question,
Mr. Ramey may be excused.

(Witness excused.)

MR. PORTER: Anything else to be offered in the case? Case will be taken under advisement and the hearing is adjourned.
