Aztec Oil & Gas Company hereby submits its application, in triplicate, for an order force-pooling all mineral interests in a non-standard 152.6-acre gas proration unit in the Aztec Pictured Cliffs Gas Pool, San Juan County, New Mexico.

In support of this application, Applicant respectfully states and shows the following:

1. Applicant is the present sole owner of the right to drill for and produce dry gas and associated hydrocarbons from the Aztec Pictured Cliffs formation under the terms of the following oil and gas lease:

Oil and Gas Lease bearing effective date of February 1, 1948, by and between the United States of America, as Lessor, and C. H. Nye, as Lessee, Serial No. NM-03561, covering, among other lands in said county and state, the following described lands in San Juan County, New Mexico:

Township 29 North, Range 10 West, N.M.P.M. Section 6: Lots 6 & 7, $NE_{\mu}^{1}SW_{\mu}^{1}$

(containing 112.6 acres, more or less)

2. Applicant owns 3/8ths of the operating rights and Ted White owns 5/8ths of the operating rights for the production of dry gas and associated hydrocarbon substances from the Aztec Pictured Cliffs formation under the terms of the following oil and gas lease:

Oil and Gas Lease bearing effective date of November 1, 1946, by and between the United States of America, as Lessor, and Bertha M. Houck, as Lessee, Serial No. SF-078717, covering, among other lands, the following:

3. The proposed non-standard unit would consist of the following:

Such non-standard unit will be subject to administrative approval pursuant to Rule 18th D-II of the Oil Conservation Commission of New Mexico.

- 4. Applicant has made a diligent effort to locate Ted White by writing to his last known address and telephoning the only known member of his family, as well as known former friends and business associates, but Applicant has been mable to contact the said Ted White.
 - 5. The denial of this application would:
 - (a) deprive, or tend to deprive, the royalty owner and overriding royalty owner under the proposed unit the opportunity to recover their just and equitable share of the hydrocarbons in the Aztec Pictured Cliffs Gas Pool;
 - (b) cause, or tend to cause, the drilling of an unnecessary well;
 - (c) cause, or tend to cause, waste in that the proposed unit would have to be developed by the drilling of two wells, which would be so economically unsound that such wells would probably never be drilled at all;

- (d) not adversely affect the correlative rights of the parties.
- 6. Should this application be favorably received by the Commission, thereby resulting in the issuance of an order force-pooling the SW_{tt}^{1} of Section 6, Township 29 North, Pange 10 West, San Juan County, New Mexico, insofar as the Aztec Pictured Cliffs formation only is concerned, the well for such Gas Proration Unit will be drilled by Applicant at an orthodox location thereon.

WHEREFORE, Applicant respectfully requests that this application be promptly set for hearing, that notices be issued pursuant to the Regulations of the Commission, and that Applicant be given opportunity at such hearing to present its evidence in support of this application, and that the Commission thereafter grant and issue its order force-pooling all mineral interest in the Gas Proration Unit above described pursuant to authority vested in it by Chapter 65, Article 3, Sec. 65-3-14 of the New Mexico Statutes 1953, Revised. Applicant further requests that such pooling order make definite provision for Ted White to make pro rata reimbursement solely out of production to Applicant for the costs of development and operation of the subject well, including a reasonable charge for supervision and a charge for the risk involved in the drilling of such well. Applicant respectfully requests that the charge for risk be deemed to be fifty per cent (50%) of the pro rata share of the cost of drillin, and completing the subject well attributable to the interest of the said Ted White.
