TRANSCRIPT OF HEARING



MR. NUTTER: We'll call Case No. 3939.

MR. HATCH: Case 3939, application of Aztec Oil and Gas Company for four unorthodox gas well locations, San Juan County, New Mexico.

MR. MORRIS: Mr. Examiner, again, I am Dick Morris, of Montgomery, Federici, Andrews, Hannahs and Morris, of Santa Fe, appearing on behalf of the applicant, Aztec Oil and Gas Company. At this time, I would like to introduce to the Examiner and the Commission staff, Mr. Joe E. Starks, an attorney for Aztec Oil and Gas Company. Mr. Starks is a member of the Texas Bar and will handle the presentation of the evidence on behalf of the applicant.

MR. NUTTER: Go ahead.

MR. STARKS: Thank you, Mr. Morris. If it please the Examiner, Aztec Oil and Gas at this time would like to respectfully request the withdrawal of its application with respect to the Hampton Well No. 4, and will proceed with the presentation of evidence with respect to its applications pertaining to the Richardson Well No. 7, the East Well No. 10, and the East Well No. 8. In this regard, Aztec Oil and Gas Company, the applicant, will present one witness only, the same being Mr. L. L. Stevens on my left.

(Witness sworm.)

MR. STARKS: Again, if it please the Examiner, because of the similarity of these applications, we would prefer to present testimony with respect to each of the three wells concurrent.

MR. NUTTER: All right, sir.

L. L. STEVENS

called as a witness, and having been first duly sworn, was examined and testified as follows:

DIRECT EXAMINATION

BY MR. STARKS:

Q ir. Stevens, for the record, would you state your name, the name of your company and your occupation?

A I'm L. L. Stevens, S-t-e-v-e-n-s, employed by Aztec Oil and Gas Company as Petroleum Engineer in Dallas, Texas.

Q Mr. Stevens, have you testified previously before this Cornission?

A Yes, sir.

MR. STARKS: Are there any questions as to Mr. Stevens' general qualifications to testify as a petroleum engineer?

MR. NUTTER: No, sir. He's qualified. Please proceed.

MR. STARKS: Thank you, Mr. Examiner.

Q Mr. Stevens, I believe that for the purpose of this

locations of the wells which are the subject matter of this application, together with other wells located in the immediate vicinity thereof, is that correct?

- A Yes
- Q Were these plats prepared by you or under your supervision?
 - A Yes, sir, they were.

MR. STARKS: At this time, Mr. Examiner, in order that you might have something to refer to in this regard, I'll go ahead and introduce them as Applicant's Exhibit Number 1 at the present time.

(Whereupon, Applicant's Exhibit Number 1 was marked for identification.)

- Q Now, Mr. Stevens, you stated that at the present time you are a petroleum engineer employed by applicant. Were you also employed by applicant at the time that the three wells in question were drilled?
 - A Yes, sir.
 - Q And when were these wells drilled, originally?
- A The Richardson No. 7 was completed in July, 1960. The East No. 8 was completed in May, 1962. The East No. 10 was completed July, 1962.

- Q Now, in what formation were each of these wells completed?
 - A Each well was completed in the Dakota Formation.
- O Have they ever been recompleted in any other zone since the date of the original completion?
 - A No, sir. They have not.
- Q Were you employed by applicant at the time that these wells were completed?
 - A Yes, sir, I was.
- Q Have you been familiar with these wells since that date?
 - A Yes.
- Q Mr. Stevens, the application at the present time is for unorthodox location from Mesaverde wells, these applications being made for dual completions to be made in these well bores. In what formation is this application made for dual completions?
 - A For the Blanco-Mesaverde Gas Pools.
- Q Let me ask you this: were these wells, when they were originally drilled and completed, drilled on orthodox locations?
 - A For the Dakota Formation, yes, they were.
- Q Now, I would ask you this, Mr. Stevens: would you discuss briefly for the benefit of this hearing the drainage pattern which would be anticipated with respect to the wells at

the locations as applied for as compared with locations at orthodox locations under the existing rules for Mesaverde wells?

A Well, in Section 26, the East No. 10, you can see with reference to this Exhibit Number 1, if this well were completed in the Blanco-Mesaverde Gas Pool at an orthodox location, we would have a bunching of wells around the northeast corner of Section 26, and it's possible that gas contained in the formation in the northwest quarter of Section 26 might eventually be wasted through underground waste.

The same is true of Richardson No. 7 in Section 15, and also for East No. 8 in Section 26, the southeast quarter.

Q Mr. Stevens, is it your opinion then, that by completing these wells at the locations as applied for, that you would accomplish a better drainage pattern for this particular reservoir than drilling the wells at orthodox locations?

A Yes, sir, I believe we would. There was a pattern established by the Mesaverde wells which were drilled some time ago and prior to the Commission's order which established spacing units for the Mesaverde and the wells for which we are making application for these unorthodox locations, they follow, generally, the pattern that has been established previously with regard to the Mesaverde.

We believe that completing the Mesaverde at these

locations will make for more efficient drainage of the Blanco-Mesaverde.

Mr. Stevens, in your opinion, insofar as the units that would be established for these various wells as applied for, in your opinion, are all portions of each of these units productive of gas in the Mesaverdo?

A Yes, sir. The Mesaverde in this area is more or less a blanket sand and all the acreage contained in the units would be presumed to be productive of gas.

Q Then, is this application made for the purpose of gaining structural position or a better productivity from the wells themselves, other than with respect to the drainage pattern based upon the location of pre-existing wells?

A No, sir. We want to develop the Mesaverde in these sections.

Q When these wells were originally drilled and completed as Dakota wells, were these wells drilled at what would be unorthodox locations in the Mesaverde for the purpose of laying the predicate as it were for applying for unorthodox locations at a later date?

A No, sir. These wells were projected to the Dakota Formation for Dakota gas wells and they were just located in the area to be on trend with the general drilling trend set up

in the are orier to the time that the wells were drilled.

- Q If the application as made were denied and it should become necessary to drill Mesaverde wells at orthodox locations pursuant to the present existing rules, would economic waste result insofar as the operators are concerned?
 - A Yes, sir, it would.
- Q With respect to the proposed dual completions of these wells, have you had occasion to contact all offset operators?
- A Yes, sir. Making application for administrative approval of dual completions, we have contacted each offset operator.
- Q Have they indicated their consent to the proposed applications?
 - A Yes, sir, through waivers.
 - Q Have all offset operators indicated their consent?
 - A Yes, sir.
- Q In your opinion, Mr. Stevens, would the granting of these applications as made result in any impairment of correlative rights to any other operator in this formation?
 - A No, sir, I don't believe it would.
- Q Then, in your opinion, would the granting of these applications as made be in the best interest of conservation and the prevention of waste?

A Yes, sir, I believe it would.

MR. STARKS: Mr. Examiner, applicant has nothing further to offer. We would respectfully request that the exhibit heretofore handed you be accepted as Applicant's Exhibit 1.

MR. NUTTER: Aztec's Exhibit Number 1 will be admitted in evidence.

(Whereupon, Applicant's Exhibit Number 1. was admitted in evidence.)

CROSS EXAMINATION

BY MR. NUTTER:

Q Mr. Stevens, it appears from just a casual survey of your plat that there are about as many wells on pattern as there are off pattern in the Mesaverde in this area.

A Yes, sir, there are about eighteen wells here and approximately ten of them are off pattern and they were drilled prior to the order which established the --

- Q That's what I understood. You said that this area was developed on this on-pattern prior to the establishment of the Blanco-Mesaverde Pool rules.
 - A Yes, sir.
- Q Which requires that wells be in the northeast and the southwest quarters.

- A That is correct, yes, sir.
- Q Now, I notice here in Section 23, you have three Mesaverde wells. How is that acreage dedicated, Mr. Stevens?
- A The east half of this section is dedicated to the Hedges No. 1 and No. 2 Well. The No. 2 is a dual completion in the Dakota and the Mesaverde. The No. 1 Well is a singly completed well in the Mesaverde, and both of these wells produced the one allowable for this east half of this Section 23.
 - Q So those two wells share that half?
 - A Yes, sir.
 - Q And the west half is dedicated to the No. 2?
 - A Yes, sir.
- Q Now, do you propose to complete these as Mesaverde wells, or will they be dually completed?
 - A They will be dually completed, we propose.
- Q And that also applies to the Richardson No. 7 up here in Section 15?
- A Yes, sir, the Richardson 7, East 8 and East 10. We propose to dually complete all of them.

MR. NUTTER: Are there any other questions of Mr. Stevens? He may be excused. Do you have anything further, Mr. Bonnette?

MR. BONNETTE: Nothing further, Mr. Examiner.

MR. NUTTER: Does anyone have anything they wish to offer in Case No. 3939?

MR. HATCH: The Commission has received a letter from Vernon Neuhaus waiving objection to the wells in Section 22 location -- objection to the locations in Section 26, and the other is a letter from Pan American Petroleum Corporation waiving objection to the location of the Hampton No. 4, which has been dismissed.

MR. NUTTER: Thank you. Is there anything further in Case 3939? We'll take the case under advisement.

ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 a.m. on November 12, 1968, at Santa Fe, New Mexico, before Examiner Daniel S. Nutter.

NOW, on this 21st day of Movember, 1968, the Commission, a quorum being present, having considered the testimony, the record, and the recommendations of the Examiner, and being fully advised in the premises,

FINDS:

- (1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.
- (2) That the applicant, Aztec Oil & Gas Company, saeks approval of unorthodox gas well locations in the Blanco-Mesaverds Gas Pool for its following-described wells in Township 31 North, Range 12 West, NMPM, San Juan County, New Maxico:

Richardson Well No. 7 located 1621 feet from the South line and 1584 feet from the East line of Section 15:

East Well No. 10, located 1770 feet from the North line and 790 feet from the West line of Section 26; and

-3-CASE No. 3939 Order No. R-3584

East Well No. 8 located 790 feet from the South line and 790 feet from the East line of Section 26.

- (3) That the subject wells were drilled and completed as Dakota gas wells at standard locations for the Basin-Dakota Gas Pool, and are off-pattern with respect to the Special Rules and Regulations governing the Blanco-Mesaverde Gas Pool.
- (4) That a number of the wells in the subject area completed as Mesaverde wells were completed in that formation before the establishment of the present spacing rules for the Blanco-Mesaverde Gas Fool and are off-pattern for said pool.
- (5) That the applicant proposes to dually complete each of the subject wells in the Basin-Dakota Gas Pool and the Blanco-Mesaverde Gas Pool.
- (6) That approval of the subject application will afford the applicant the opportunity to produce its just and equitable share of the gas in the Blanco-Mesaverde Gas Pool, will prevent the economic loss caused by the drilling of unnacessary wells, avoid the augmentation of risk arising from the drilling of an excessive number of wells, and otherwise prevent waste and protect correlative rights.
- (7) That applicant's request, its application for a fourth unorthodox gas well location in this case should be <u>dismissed</u>.

IT IS THEREFORE ORDERED:

(1) That the applicant, Artec Cil & Gas Company, is hereby authorized unorthodox gas well locations in the Blanco-Mesaverde Gas Pool for its following-described wells in Township 31 North, Range 12 West, NMPM, San Juan County, New Mexico:

Richardson Well No. 7 located 162% feet from the South line and 1584 feet from the East line of Section 15;

East Well No. 10 located 1770 feet from the Forth line and 790 feet from the West line of Section 26; and

-3-CASE No. 3939 Order No. R-3584

East Well No. 8 located 790 feet from the South line and 790 feet from the East line of Section 26.

- (2) That the applicant's request for dismissal of a fourth unorthodox location originally requested in this case is hereby granted.
- (3) That jurisdiction of this cause is retained for the entry of such further orders as the Commission may deem necessary.




