- The point selected was on the gathering pipeline entering South Eddy Gas Plant at 32.166389, -103.828956.

Facility Detail Notes:

Name selected for the facility was Enterprise Carlsbad GS.

Date the facility was opened – per Corey Smith use the oldest date or decade known. Since circa 1950 is the oldest date known, then 01/01/1951 was entered.

Depth to ground water – if known – per Corey Smith NA is acceptable and once entered the OCD Form defaulted to 0. So NA was entered and since system then defaults to 0.
