Good afternoon-

I'm writing to provide an update for Sundance Services, Inc. (SSI) (Commercial Surface Waste Management Facility Permit NM1-3) in regard to Milestone #4 of the approved Closure/Post-Closure Plan (CPC Plan) submitted to the New Mexico Energy, Minerals and Natural Resources Division (EMNRD) Oil Conservation Division (OCD) on September 29, 2016 and approved on July 31, 2017. The description of Milestone #4, as approved, is: "Draining of all process liquids and decommissioning of facility Ponds 5 and 6 on or before December 31, 2020."

As of December 31, 2020, all SSI piping and equipment to convey liquids to these ponds had been removed, all free standing liquid from both ponds had been removed, and earthwork had been completed to move site soils into Pond 5. Therefore, SSI has met the requirements of Milestone #4. Additional information regarding this milestone will be included in the 2020 annual report, which will be submitted to OCD within 45 days of December 31, 2020, as required.
