Delek Field Services, LLC (DKL FS) is respectfully submitting a revised C-147 form in response to your email of February 15, 2024, as part of our request to extend the Cessation of Operations for the subject facility. We are requesting this extension for the period of March 8, 2024, through September 8, 2024.

Market conditions beyond our control in Eddy County have prevented us from reaching the 20% recycle requirement for our Carlsbad 960/Dark Canyon Produced Water Impound facility. However, we anticipate an increase in oil and gas drilling operations in late Spring 2024 that will increase our ability recycle produced water at our facility.

This facility is essential for the reduction of freshwater usage and demand in Eddy County from oil and gas drilling operations. We provide produced water in place of freshwater for drilling operations, in turn preserving the freshwater for agriculture, livestock and other types of human consumption. This process provides much needed relief for the withdrawal of groundwater in Eddy County.

Outside of market conditions, DKL FS continues to show good cause in operating this facility. DKL FS and the previous facility owner (3Bear Field Services), as previously communicated, have invested millions of dollars in equipment, engineering services, geologic analysis to operate this facility since 2019. It is a key piece of DKL FS's recycling operations.

Allowing this facility to remain in operation also ensures the safe transportation, disposal, and recycle of produced water in Eddy County. Unlike many of our competitors, we do not use "lay flat line" for the transportation of produced water for recycling. DKL utilizes HDPE line which is more rugged due to the local terrain. While this limits our

access to certain opportunities to recycle, it is in the best interest of the environment due to the higher risk associated with spills and leaks from lay flat line. Our approach of using only environmentally safe transportation methods of produced water far outweighs the lost opportunities for produced water recycling.

As market conditions improve, our Dark Canyon 960/Carlsbad facility will provide a viable long-term solution for the safe and effective management of Produced Water to the Oil & Gas industry in Eddy County freeing up freshwater for other uses. Please find the attached C-147 for your review.

We appreciate your reconsideration of the Agency's February 15, 2024, request to submit a Cessation of Extension or proceed towards closure and your assistance with this request for our efforts to continue operation of this facility. NMOCD has reviewed the cessation of operations extension request for 2RF-139 - Carlsbad 960/Dark Canyon Produced Water Impound Facility ID [fBGB1911347430], received from [372603] DKL Field Services, LLC on March 8, 2024, Application ID 321600. The extension of the cessation of operations is approved with the following conditions of approval:

- 2RF-139 Carlsbad 960/Dark Canyon Produced Water Impound Facility ID [fBGB1911347430] registration/permit expires on <u>April 23, 2024</u>.
- 2RF-139 Carlsbad 960/Dark Canyon Produced Water Impound Facility ID [fBGB1911347430]
 extension of cessation of operations is approved from March 8, 2024, to September 8, 2024.
 However, if after this 6-month period, the containment was not utilized at a minimum of 20%
 fluid capacity, no additional extensions would be granted, and the operator would be directed
 to remove all fluids and proceed with the closure requirements.
- [372603] DKL Field Services, LLC will maintain a liquid level in the containment that is at least equal to the weight of the liner plus 20%. [372603] DKL Field Services, LLC may maintain a higher liquid level if they choose.
- [372603] DKL Field Services, LLC will provide written notice to <u>OCD Online</u> at least 72 hours, but no more than one week, prior to the recommencement of operations. Recommencement of recycling operations means that the operator plans to resume moving fluids through the containment and discharging fluids from the containment.
 - At the resumption of recycling operations, [372603] DKL Field Services, LLC is required to perform an incremental fluid level test for containment liquid levels above the minimum liquid level.
 - o [372603] DKL Field Services, LLC will fill the containment. [372603] DKL Field Services, LLC will pause filling operations at every 10% of total fluid capacity above the minimum level.
 - o [372603] DKL Field Services, LLC will maintain the liquid level for each 10% volume increase for 24 hours and inspect and operation the leak detection system at the end of the 24-hour period.
 - If there are no liquids present in the leak detection system, [372603] DKL Field Services, LLC may proceed to fill the next 10% volume and repeat the process until the containment full design capacity minus the 3-feet of freeboard is reached.
 - If liquids are present, [372603] DKL Field Services, LLC should immediately cease the incremental fill
 test and perform a liner inspection. [372603] DKL Field Services, LLC should provide written notice of
 the fluid detection and liner inspection findings to OCD via OCD Online using a C-147 (long form) with
 the "Other" box checked and "Notice of fluid detection" written as the explanation of "Other."
 - Upon notification of fluid detection in the leak detection system, the OCD will verify the source of water (condensation versus produced water).
 - o If the detected fluid is confirmed to be condensation, the OCD will issue a written approval to proceed with the incremental fluid level test.

- If the detected fluid is confirmed to be produced water, [372603] DKL Field Services, LLC must comply with 19.15.34.13 NMAC. [372603] DKL Field Services, LLC must provide written notification to OCD Online on the actions taken to comply with 19.15.34.13 NMAC.
- After fluid is detected in the leak detection system, the incremental fill test cannot continue until after a written approval to proceed is issued by the OCD.
- o [372603] DKL Field Services, LLC must submit copies of the detailed containment inspection records for the prior three months and a report detailing the incremental fluid level test process and results through the OCD Online system using a C-147 (long form) with the "Other" box checked. "Recommencement of Operations Incremental Fluid Level Test" should be written as the explanation of "Other." Form C-147 must be completed and include information in sections 1 General Information, 2 Recycling Facility, 3 Recycling Containment, 4 Bonding, and 10 Operator Application Certification. Section 9 Recycling Facility and/or Containment Checklist may also need to be partially completed. Operators should verify that the resumption of operations notification does not result in any changes to the recycling containment operating and maintenance plan or the closure plan. If the recommencement of operations will affect the operating and maintenance plan or closure plan, operators should check those boxes in section 9 and provide updated plans or plan addendums as attachments to the C-147.
- [372603] DKL Field Services, LLC will continue to operate, maintain, and close 2RF-139 Carlsbad 960/Dark Canyon Produced Water Impound Facility ID [fBGB1911347430] in compliance with 19.15.34 NMAC, to include but not limited detailed inspection records, removal of trash/oil from containment, and monthly C-148 reporting (even if there is zero activity).
- A minimum of 3-feet freeboard must always be maintained in the recycling containment during operations.
