The registration/permit extension request is approved with the following conditions of approval:

- 1RF-17 SALADO DRAW RECYCLING FACILITY NORTH RECYCLING CONTAINMENT FACILITY ID [fOY1720932432] is approved for one (1) year of operation from the date of the previous registration/permit expiration date of July 11, 2024. The new registration/permit expiration date is July 11, 2025.
- [14744] MEWBOURNE OIL CO will continue to operate, maintain, and close the 1RF-17 SALADO DRAW RECYCLING FACILITY NORTH RECYCLING CONTAINMENT FACILITY ID [fOY1720932432] in compliance with 19.15.34 NMAC, to include but not limited to the performance of weekly inspections regardless of fluid levels in the containment; recording of detailed inspection reports; removal of debris, foreign objects and oil from the containment; and monthly reporting of recycling and reuse of produced water, drilling fluids, and liquid oil field waste via from C-148.
- [14744] MEWBOURNE OIL CO will maintain a liquid level in the containment that is at least equal to the weight of the liner plus 20%. [14744] MEWBOURNE OIL CO may maintain a higher liquid level if they choose.
- If less than 20% of the total fluid capacity is utilized every consecutive six months, operation of the facility is considered ceased and notification of cessation of operations should be sent electronically to <u>OCD Online</u>. An extension to extend the cessation of operations, not to exceed six months, may be submitted using a C-147 Long form through the <u>OCD Online</u> system.
