Summary of Daily Activity	Daily activities of excavation and loading contaminated soil continued. A total of 340 cy of soil was hauled out to Envirotech's Landfarm. Confirmation samples were collected from the upper portions of the North, West and East walls. Field screening of the base of the excavation continued to show elevated VOCs (>1000 ppm) and TPH (~4000 ppm) readings. A total of \$2,554.35 in unaccounted cost for non-Bid items was incurred.
