<u>ORDER</u>

The Director of the New Mexico Oil Conservation Division ("OCD"), having heard this matter through a Hearing Examiner on October 9, 2025, and after considering the testimony, evidence, and recommendation of the Hearing Examiner, issues the following Order.

FINDINGS OF FACT

- 1. E.G.L. Resources, Inc. ("Operator") submitted an application ("Application") requesting an extension to drill the well(s) as required by Order R-23498, as amended ("Order").
- 2. Operator identified the owners of uncommitted interests in oil and gas minerals in the Unit and provided evidence that notice of the Application was given.
- 3. Operator has demonstrated good cause to extend the deadlines in the Order.
- 4. The Application was heard by the Hearing Examiner, during which Operator presented evidence through affidavits in support of the Application. No other party presented evidence at the hearing.
- 5. Exhibit A of Order R-23498 contains a scrivener's error in the "Description: TRS/County" section whereby Range 35 East was incorrectly listed and should have been Range 33 East.

CONCLUSIONS OF LAW

- 6. OCD has jurisdiction to issue this Order pursuant to NMSA 1978, Section 70-2-17.
- 7. Operator satisfied the notice requirements for the Application and the hearing as required by 19.15.4.12 NMAC.
- 8. OCD satisfied the notice requirements for the hearing as required by 19.15.4.9 NMAC.

ORDER

9. The period to drill the well(s) is extended until October 23, 2026.

- 10. This Order shall terminate automatically if Operator fails to comply with Paragraph 8 unless prior to termination Operator applies, and OCD grants, to amend the Order for good cause shown.
- 11. OCD retains jurisdiction of this matter for the entry of such orders as may be deemed necessary.
- 12. The remaining provisions of the Order remain in force or effect.
- 13. Exhibit A of Order R-23498 is hereby replaced with amended Exhibit A attached.
