ORDER NO. AG-N-33-B

SUPPLEMENTAL GAS PRORATION ORDER FOR THE MONTH
OF SEPTEMBER, 1971

The Commission held public hearing at Santa Fe, New Mexico, on August 18, 1971, at 9 a.m., pursuant to legal notice, for the purpose of setting the allowable production of gas from the following nine gas pools in San Juan, Rio Arriba, and Sandoval Counties, New Mexico, for the month of September, 1971.

Basin-Dakota, Blanco-Mesaverde, Aztec-Pictured Cliffs, Ballard-Pictured Cliffs, Blanco-Pictured Cliffs, South, Fulcher Kutz-Pictured Cliffs, Kutz-Pictured Cliffs, West, Tapacito-Pictured Cliffs, and Devils Fork-Gallup.

NOW, on this 19th day of August, 1971, the Commission, a quorum being present, having considered the supplemental nominations of purchasers, the capacity of producing wells, and being otherwise fully advised in the premises,

FINDS:

(1) That the total nomination of purchasers of gas produced from the above-listed nine gas pools for the month of September, 1971, is 45,254,200 Mcf. The individual pool nominations are as follows:

Aztec-Pictured Cliffs	966,500 Mcf
Ballard-Pictured Cliffs	1,180,900 Mcf
Blanco-Pictured Cliffs, South	3,022,200 Mcf
Fulcher Kutz-Pictured Cliffs	644,200 Mcf
Kutz-Pictured Cliffs, West	353,700 Mcf
Tapacito-Pictured Cliffs	862,500 Mcf
Devils Fork-Gallup	89,500 Mcf

(2) That the potential producing capacity of all gas wells in the nine gas pools listed above is in excess of the nominations of purchasers of gas, and in order to prevent waste and protect correlative rights, the production of gas from the above-listed nine gas pools should be limited, allocated, and distributed during the month of September, 1971.

(3) That all the producing gas wells, together with the expected completed or recompleted wells in the nine gas pools listed above, can produce a total of 45,254,200 Mcf without causing waste during the month of September, 1971, and an allocation based upon such production would be reasonable and would protect correlative rights.

IT IS THEREFORE ORDERED:

(1) That for the month of September, 1971, the allowable production to be assigned the nine allocated gas pools in San Juan, Rio Arriba, and Sandoval Counties, New Mexico, is as follows:

Kutz-Pictured Cliffs, West	353,700 Mcf
Tapacito-Pictured Cliffs	862,500 Mcf
Devils Fork-Gallup	89,500 Mcf


(2) That the allocation hereby set for the month of September, 1971, in the nine allocated pools in San Juan, Rio Arriba, and Sandoval Counties, New Mexico, shall be in accordance with the Commission Rules, Regulations, and Orders.

(3) That a proration schedule, duly prepared by the Commission and thereafter adopted for the month of September, 1971, is hereto attached and made a part hereof; it distributes and allocates the allowable production among the gas wells in the nine gas pools listed above for the period stated, in accordance with the Commission Rules, Regulations, and Orders.


The foregoing order shall remain effective until further order of the Commission.
