MEXICO.

ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on April 15, 1964, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 21st day of April, 1964, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That there is need for the creation of a new pool in Roosevelt County, New Mexico, for the production of oil from the San Andres formation, said pool to bear the designation of Allison-San Andres Pool. Said Allison-San Andres Pool was discovered by Nearburg & Ingram, Anderson No. 7, located in Unit H of Section 31, Township 8 South, Range 37 East, NMPM. It was completed in San Andres on December 28, 1963. The top of perforations is 4861 feet.

(3) That there is need for the creation of a new pool in Roosevelt County, New Mexico, for the production of oil from the San Andres formation, said pool to bear the designation of North Allison-San Andres Pool. Said North Allison-San Andres Pool was discovered by Marathon Oil Company, Milton Basham "A" No. 1, located in Unit D of Section 19, Township 8 South, Range 37 East, NMPM. It was completed in San Andres on February 2, 1964. The top of perforations is 4920 feet.

(4) That there is need for the creation of a new pool in Lea County, New Mexico, for the production of gas from the Pennsylvanian (Morrow) formation, said pool to bear the designation of Antelope Ridge-Morrow Pennsylvanian Gas Pool. Said Antelope Ridge-Morrow Pennsylvanian Gas Pool was discovered by Shell Oil Company, Antelope Ridge Unit No. 4-1, located in Unit B of Section 4, Township 24 South, Range 34 East, NMPM. It was completed in Pennsylvanian (Morrow) on May 20, 1963. The top of perforations is 12,898 feet.

(5) That there is need for the creation of a new pool in Lea County, New Mexico, for the production of oil from the San Andres formation, said pool to bear the designation of Flying "M"-San Andres Pool. Said Flying "M"-San Andres Pool was discovered by Coastal States Gas Prod. Company, Skelly State No. 1, located in Unit F of Section 21, Township 9 South, Range 33 East, NMPM. It was completed in San Andres on February 24, 1964. The top of perforations is 4502 feet.

(6) That there is need for the creation of a new pool in Lea County, New Mexico, for the production of gas from the Paddock formation, said pool to bear the designation of North Paddock Gas Pool. Said North Paddock Gas Pool was discovered by Aztec Oil & Gas Company, State No. 9, located in Unit F of Section 2, Township 21 South, Range 37 East, NMPM. It was completed in Paddock on June 7, 1962. The depth to casing shoe is 5682 feet.

(7) That there is need for the creation of a new pool in Eddy County, New Mexico, for the production of oil from the San Andres formation, said pool to bear the designation of Tamano-San Andres Pool. Said Tamano-San Andres Pool was discovered by William A. & Edward R. Hudson, Lowe Federal No. 1, located in Unit P of Section 35, Township 17 South, Range 31 East, NMPM. It was completed in San Andres on August 1, 1963. The top of perforations is 4307 feet.

(8) That there is need for the consolidation of the North Justis-Blinebry Pool and the Justis-Blinebry Pool, Lea County, New Mexico, inasmuch as the pools produce from the same formation and whose horizontal limits are contiguous. Said consolidation to be accomplished by the abolishment of the North Justis-Blinebry Pool.

(9) That there is need for the deletion of certain acreage from the Loco Hills Pool and the extension of the Artesia Pool to include said acreage in order that all wells in the same basic lease will be in one pool. Both pools are in Eddy County, New Mexico.

(10) That there is need for certain extensions to the Atoka-San Andres Pool, the North Hackberry-Yates Pool, and the Shugart Pool, all in Eddy County, New Mexico, the Milnesand-San Andres Pool in Roosevelt County, New Mexico, the South Brunson-Ellenburger Pool, the Drinkard Pool, the Flying "M"-Abo Pool, the Gladiola-Wolfcamp Pool, the Inbe-Pennsylvanian Pool, the Justis-Blinebry Pool, the North Justis Tubb-Drinkard Pool, the Kemnitz-Wolfcamp Pool, the Lusk-Strawn Pool, the Mescalero-San Andres Pool, the Monument-Tubb Pool, the Oil Center-Blinebry Pool, the Paddock Pool, the Scharb-Bone Springs Pool, the Vacuum-Abo Reef Pool, and the East Weir-Blinebry Pool, all in Lea County, New Mexico.
