ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on February 16, 1955, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission".

NOW, on this 20th day of March, 1955, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That extensions as advertised should be approved for the West Kutz-Pictured Cliffs, South Blanco-Pictured Cliffs, Aztec-Pictured Cliffs and Fulcher Kutz-Pictured Cliffs Gas Pools.

IT IS THEREFORE ORDERED:

That the application of the Oil Conservation Commission of New Mexico be, and the same hereby is, approved as follows:

(a) That the West Kutz-Pictured Cliffs Pool boundary, as heretofore classified, defined and described, should be extended to include:

TOWNSHIP 26 NORTH, RANGE 10 WEST, NMPM
E/2 Section 4

TOWNSHIP 27 NORTH, RANGE 10 WEST, NMPM
SE/4 Section 33

TOWNSHIP 27 NORTH, RANGE 12 WEST, NMPM
NE/4 Section 9

TOWNSHIP 29 NORTH, RANGE 12 WEST, NMPM
All Section 28

(b) That the South Blanco-Pictured Cliffs Gas Pool boundary, as heretofore classified, defined and described, should be extended to include:

TOWNSHIP 26 NORTH, RANGE 5 WEST, NMPM
S/2 Section 29; S/2 Section 30
 all of Section 32

(c) That the Aztec-Pictured Cliffs Pool boundary, as heretofore classified, defined and described, should be extended to include:

TOWNSHIP 30 NORTH, RANGE 10 WEST, NMPM
 All of Sections 34 and 35

(d) That the Fulcher Kutz-Pictured Cliffs Gas Pool boundary, as heretofore classified, defined and described, should be extended to include:

TOWNSHIP 28 NORTH, RANGE 10 WEST, NMPM
 All of Sections 25 and 36

TOWNSHIP 29 NORTH, RANGE 12 WEST, NMPM
E/2 Section 14
