ORDER OF THE COMMISSION

BY THE COMMISSION:

This matter came on for hearing at Santa Fe, New Mexico, on December 22, 1950, on the motion of the Oil Conservation Commission and on the recommendation of the Northwestern New Mexico Nomenclature Committee, the Commission having heard the evidence presented and being duly advised finds:

1. That it has jurisdiction of this matter and the parties interested therein, due notice having been given of this hearing.

2. The several areas hereinafter described each comprise a separate common reservoir of gas in the producing horizon designated and are each gas pools as follows:

3. Certain existing gas reservoirs have been extended by recent development and the following lands should be added to and embraced within the gas pools as follows:

4. The name of the Fulcher Basin-Kutz Canyon (Pictured Cliffs) gas pool should be changed to Fulcher-Kutz (Pictured Cliffs) gas pool, and due to recent developments said pool should be extended so as to include the following lands:

✓ Township 27 North, Range 9 West:

All Section 8  
All Sec. 17  
S/2 Sec. 18

✓ Township 28 North, Range 10 West:

SW/4 Section 25  
SE/4 Section 26

5. The area hereinafter described comprises a separate common reservoir of oil producing from the Dakota horizon and said area should be named, designated and defined as the Stoney Butte (Dakota) oil pool as follows:

Township 21 North, Range 13 West:

W/2 Section 6  
W/2 Section 7

Township 22 North, Range 13 West:

W/2 Section 31

Township 21 North, Range 14 West:

E/2 Section 1  
E/2 Section 12

Township 22 North, Range 14 West:

E/2 Section 36

IT IS THEREFORE ORDERED that the above described areas are classified, named and defined as oil or gas pools as set forth above.
