A hydrocarbon release from a UST removed from the D Plant Area was first reported to the NMOCD in December 1987. Elevated levels of nitrate in groundwater were discovered in a monitoring well completed adjacent to the South Flare Pit during an Plant-wide investigation, documented in the January 1989 Groundwater Investigation Report by Bechtel Environmental. It was concluded from the investigation the source of the nitrate was from an upgradient source. Subsequent investigations on the Blanco Plant completed in 1990 and 2003 revealed elevated levels of nitrate both around the South Flare Pit and the D Plant area of the Blanco Plant. While various Blanco Plant operations have used nitrate-containing materials, no known source or specific releases were identified. The South Flare Pit was excavated and closed in 1993.
