He stated a large dust devil went through his property and that may have been where the spots came from. Personnel from District 3 notified us of the complaint & inspected our facility for release source. NMOCD personnel could not find a definitive source of the release as there were no indications that it came from our facility. There is a wellsite on the east side of our facility near the adjacent property and there is also a main roadway between our property and landowner. It could not be determined that the release was from our property, the wellsite, or a vehicle traveling down the roadway. Although there are no indications the source of the release was from our facility, we are completing this C-141 at the direction of the Bureau Chief. The amount of the release is undetermined as it appears to be a small amount of material that was blown onto the landowner's vehicles from an unknown source, estimated to be less than 1 BBL.
