Cause of the fire was due to material failure from vibration rubbing a hole in a rubber hose, causing the fire to start. The fire was out when the Operator arrived and no emergency personnel were required to extinguish the fire. There was no product loss or damage to property, other than damage to the pump, and no injuries reported. The rubber hose will be replaced with a steel braided hose rated for natural gas use. |
