

To Whom it may concern:

On behalf of Concho Operating, LLC (COG), New Tech Global Environmental, LLC (NTGE) has prepared this letter to document the liner inspection activities for the Magnum Pronto State Com 005H (08.11.21). The site is located at 32.61014°, -103.78721° within Unit O, S32, T19S, R32E, in Lea County (Figures 1 and 2).

### **Background**

Based on the initial C-141 obtained from the New Mexico Oil Conservation Division (NMOCD), the release was discovered on August 11, 2021, due to a line on the oil dump corroding. It resulted in the release of approximately six (6) barrels of crude oil. Approximately three (3) barrels of crude oil were recovered. The initial C-141 form is attached in Appendix A.

### **Site Characterization**

The site is located within a low karst area. Based on a review of the New Mexico Office of State Engineers database, there is no known water well source within a ½ mile radius of the location. The nearest identified well is located approximately 2.65 miles Northwest of the site in S19, T19S, R32E. The well has a reported depth to groundwater of 345 feet below ground surface (ft bgs). A copy of the associated *Point of Diversion Summary* report is attached in Appendix B.

### **Regulatory Criteria**

In accordance with the NMOCD regulatory criteria established in 19.15.29.12 NMAC, the following criteria were utilized in assessing the site.

- Benzene: 10 milligrams per kilogram (mg/kg).
- Benzene, toluene, ethylbenzene, and total xylenes (BTEX): 50 mg/kg.
- TPH: 100 mg/kg (GRO + DRO + MRO).
- Chloride: 600 mg/kg.

**Liner Inspection**

On November 9, 2021a, 3<sup>rd</sup> party company conducted liner inspection activities to assess the liner's integrity within the facility. The personnel proceeded to inspect the liner visually. The liner was found to be intact with no integrity issues. Refer to the Photolog.

**Conclusions**

Based on the liner inspection throughout the facility, no further actions are required at the site. The final C-141 is attached, and COG formally requests closure of the spill. If you have any questions regarding this report or need additional information, please contact us at 432-813-0263.





