Mr. Bratcher:

On behalf of Concho Operating, LLC (COG), New Tech Global Environmental, LLC (NTGE) has prepared this letter to document the liner inspection activities for the Potato Baby State 034H CTB (08.10.21). The site is located at 32.002455°, -104.075836° within Unit H, S34, T26S, R28E, and approximately 15.36 miles south of Malaga, New Mexico, in Eddy County (Figures 1 and 2).

Background

Based on the initial C-141 obtained from the New Mexico Oil Conservation Division (NMOCD), the release was discovered on August 10, 2021. It resulted in an approximately unknown amount release, and zero (0) barrels of fluids were recovered due to a fire burning off all freestanding liquids. The initial C-141 form is attached in Appendix A.

Site Characterization

The site is located within a medium karst area. Based on a review of the New Mexico Office of State Engineers and USGS databases, there is no known water well source within a ½ mile radius of the location. The nearest identified well is located approximately 1.38 miles Southeast of the site in S27, T26S, R28E. The well has a reported depth to groundwater of 145 feet below ground surface (ft bgs). A copy of the associated USGS – *National Water Information System* report is attached in Appendix B.

Regulatory Criteria

In accordance with the NMOCD regulatory criteria established in 19.15.29.12 NMAC, the following criteria were utilized in assessing the site.

- Benzene: 10 milligrams per kilogram (mg/kg).

- Benzene, toluene, ethylbenzene, and total xylenes (BTEX): 50 mg/kg.
- TPH: 100 mg/kg (GRO + DRO + MRO).
- Chloride: 600 mg/kg.

Liner Inspection

On December 2, 2021, New Tech Global Environmental conducted liner inspection activities to assess the liner's integrity within the facility. NTGE personnel proceeded to inspect the liner visually. The liner was found to be intact with no integrity issues. Refer to the Photolog.

Conclusions

Based on the liner inspection throughout the facility, no further actions are required at the site. The final C-141 is attached, and COG formally requests closure of the spill. If you have any questions regarding this report or need additional information, please contact us at 432-813-0263.




