Please explain reason for why this event was beyond this operator's control	Cimarex brought the Da Vinci 7-18 CTB back online and since it is close to Scoter caused a compressor station to go down causing high line pressure, both of those wells bumped the flare due to flush volumes coming in harder than we thought. We didn't want to choke back while trying to get the wells to unload because it would cause them to load back up / struggle to unload, so we tried to keep flare to a minimum but it was necessary to get the wells kicked back off
Steps taken to limit the duration and magnitude of vent or flare	As noted Cimarex didn't want to choke back while trying to get the wells to unload because it would cause them to load back up / struggle to unload, so we tried to keep flare to a minimum but it was necessary to get the wells kicked back off.
