For this event, this operator could not have reasonably anticipated the current event and it was beyond this operator's control.	True
Please explain reason for why this event was beyond this operator's control	Appeared that isolation valve below a 2" riser allowed a small amount of liquid to leak by and fill the riser at the end of the meter tube with liquid. Liquid froze and split the pipe. Harvest could not have known that this small amount of liquid had leaked by the valve and that such a small amount of liquid would cause the pipe to split after a freeze. Please note that Harvest discovered this release at 4:02 PM on 2/4/22. It was only after review of electronic data that it was determined the leak began on 2/3/22
Steps taken to limit the duration and magnitude of vent or flare	Upon being informed of leak, Harvest personnel immediately contacted external operator that reported the leak and walked them through the steps of isolating the line where the leak was located. This prevented further gas loss to atmosphere
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	Compromised pipe was replaced and new valve was installed
