The failure was the result of an electric motor failure. There is no manufacturer's recommended maintenance on the electric motor. The failure point could not have been predetermined.
Steps taken to limit the duration and magnitude of vent or flare	Gas was flared until the electric motor could be replaced and the unit could be restarted.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	The electric motor on the air compressor was replaced. The unit was then restarted, and normal operations resumed. Flaring ceased.
