These malfunctions resulted in an intermittent flaring for a duration of 31 minutes.
Steps taken to limit the duration and magnitude of vent or flare	All of the facilities and emissions control devices at this site are operating as designed and, where applicable, are authorized. Chevron field personnel will execute practicable measures to minimize emissions.
