The leak was discovered in the morning and the amount was 6 to 8 bbls. of produced water only. Several calls were made for a vac truck and hot oil truck to help, but none were available until late afternoon, causing the treater to drain completely. All fluids were contained in the berm and estimated volume 62 bbls. with 60 bbls. recovered; 18 bbls of oil and 42 bbls of produced water. We notified Mike Bratcher, NMOCD, by phone and Jim Amos, BLM, also by phone.
