On behalf of Devon Energy Production Company (Devon), New Tech Global Environmental, LLC (NTGE) has prepared this letter to document the liner inspection activities for the Maldives 15 CTB 1 (Site). The Site is located in Eddy County approximately 19 miles east of Loving, New Mexico (Figures 1 and 2).

### **Background**

Based on the initial C-141 obtained from the New Mexico Oil Conservation Division (NMOCD), the release was discovered on December 16, 2021. The release was the result of a produced water line rupture in the tank battery. The leak resulted in the release of approximately 8.33 barrels of produced water into the lined secondary containment of which 7 bbls were recovered. The initial C-141 form is attached.

### **Site Characterization**

The Site is located within a low karst area. Based on a review of the New Mexico Office of State Engineers and USGS databases, there is no known water source within a ½ mile radius of the location. The nearest identified well is located approximately 1.63 miles northwest of the Site in S4, T23S, R31E. The well has a reported depth to groundwater of 168 feet below ground surface (ft bgs). A copy of the site characterization information and the associated *Point of Diversion Summary* report is attached.

### **Regulatory Criteria**

In accordance with the NMOCD regulatory criteria established in 19.15.29.12 NMAC, the following criteria are applicable to the Site.

- Benzene: 10 milligrams per kilogram (mg/kg).
- Benzene, toluene, ethylbenzene, and total xylenes (BTEX): 50 mg/kg.
- TPH: 100 mg/kg (GRO + DRO + MRO).
- Chloride: 600 mg/kg.

### **Liner Inspection**

On February 14<sup>th</sup> 2022, NTGE conducted liner inspection activities to assess the liner's integrity within the facility. NTGE personnel proceeded to conduct a visual inspection of the liner. The liner was found to be intact with no integrity issues. A photgraphic log documenting the condition of the liner at the time of the inspection is attached.

### **Conclusions**

Based on the finding of the liner inspection, no further actions are required at the Site. The final C-141 is attached and Devon formally requests a no further action designation for the release. 


