Please explain reason for why this event was beyond this operator's control	Inclement weather caused a brief power failure which resulted in an emergency shutdown of the station. This emergency shutdown resulted in flaring.
Steps taken to limit the duration and magnitude of vent or flare	All of the facilities and emissions control devices at this site are operating as designed and, where applicable, are authorized. Chevron field personnel will execute practicable measures to minimize emissions. Field specialists got to the compressor station and brought the station back online and flaring ended.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	Corrective measures focused on reducing gas production as quickly and safely as possible to minimize the duration and volume of gas flared. Once field specialists arrived at the compressor station the station was brought back online as soon as possible.
