1. Reason why this event was beyond Operator's control:

In this case, there were three (3) occurrences of flaring where multiple gas compression equipment malfunctioned at several facilities within the Corral area, suddenly and without warning, which then triggered small intermittent occasions of flaring to occur at the Corral 2 South compressor station, as the flare at this location can accommodate a higher volume of gas and to protect equipment, environment, and personnel. First occurrence happened from approximately 08:10 AM to 10:20 AM, which lasted roughly about 2 hours and 10 minutes, 2nd occurrence was approximately 30 minutes, from 11:40 AM to 12:10 PM, and final occurrence was approximately 28 minutes, from 03:30 PM to 04:10 PM. In each occurrence, multiple gas compressors across the Corral area malfunctioned due to detonation, bad valves, overheating, sensor issues, etc., and caused gas compression units to automatically shut down. When field personnel received compression malfunction and flaring alarms, they responded to each alarm received as quickly and safely as possible. Field personnel would immediately, upon arrival to the alarming facility, troubleshoot the compressor malfunction issues before clearing alarm panels and restarting compression equipment. In the first instance, in which a compressor mechanic was needed, Oxy requested again that USA compression allow its compressor mechanic to stay with Oxy field personnel as the extreme temperatures in the area had been affecting the equipment the day before and causing them to malfunction repeatedly. Oxy field personnel and the USA Compression mechanics responded to each compression malfunction alarm and quickly took steps to get the units back up and running at optimized efficiency. OXY made every effort to control and minimize emissions as much as possible.

Oxy continually strives to maintain and operate all its facility locations equipment in a manner consistent with good practices for minimizing emissions and reducing the number of emission events. Oxy has a strong and positive compression equipment preventative maintenance program in place. The only actions that Oxy can take and handle that is within its control, is to continue with its compression equipment preventative maintenance program for all its facilities and continually work with its compression rental owners during periods of extreme weather temperature conditions affecting facility equipment to resolve those issues in a timely manner, should they occur suddenly and without warning.
