Chevron field personnel will execute practicable measures to minimize emissions. Alarms were reset and the station was brought back online which ended the flaring.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	Corrective measures focused on reducing gas production as quickly and safely as possible to minimize the duration and volume of gas flared.
