This allowed production from a second oil tank to spill out of the LACT load line, into the LACT containment and onto the well pad and the ETC right-of-way. Total spilled 188 barrels oil, 28 barrels inside containment and 160 onto pad and right-of-way. A vacuum truck recovered total of 60 barrels, 28 barrels from inside containment and 32 barrels from pad. An environmental company is scheduled to remediate the impacted soil. The containment will be washed and a liner inspection scheduled.
