This release occurred when a 1" nipple on the transfer pump suction line T failed. The 1" nipple has been replaced.

Describe Area Affected and Cleanup Action Taken.*

The release occurred within the lined facility. A final inspection has been conducted regarding the clean-up efforts made at the above mentioned lined facility. Free fluids were removed and if present the impacted gravel was removed from the liner and taken to a NMOCD approved disposal facility. The liner was inspected for damage and found to have liner integrity to contain free fluids.
