The instrument air compressor was running continuously and the quick release on the bottom of the air compressor tank stuck open. The separator appears to have lost enough air supply, causing the back pressure valves to open and sending pressure to hit the heater pop off and blowing until it reset. An estimated total of 11 barrels fluid was released inside containment and onto the well pad. A vacuum truck recovered 7 barrels from the containment. The containment will be washed and a liner inspection scheduled. Impacted soils will be remediated.
