All fluid remained on the well pad. A total of 65 barrels OBM was released, 38 barrels inside lined containment and 27 barrels on the pad. A vac truck recovered 38 barrels from the containment and 25 barrels from the well pad. Once fluid was recovered, impacted soil was scraped up and hauled to disposal. An environmental company will remediate impacted area once drilling and completion operations are completed.
