COG Operating, LLC (COG) is pleased to submit for your consideration the following closure request for the Pinto 36 State Com #001H. This release occurred on August 18, 2017 and impacted the pasture in Unit Letter I, Section 2, Township 19S, and Range 25 East. All work has been completed in accordance with the proposed remedial activities submitted to and approved by the New Mexico Oil Conservation Division (NMOCD).

BACKGROUND

The Pinto 36 State Com #001H release that occurred on August 18, 2017 is located in Unit Letter I, Section 2, Township 19S, and Range 25 East in Eddy County New Mexico. More specifically the latitude and longitude for this release are 32.689001 North and -104.447160 West.

On August 18, 2017, a hole developed in a 4-inch valve on a flowline junction due to corrosion. The failure resulted in the release of approximately thirty-three (33) barrels (bbls) of produced water into the pasture. A vacuum truck was dispatched to recover all freestanding fluids. Approximately thirty (30) bbls of produced water were recovered.

A site assessment was conducted in order to vertically and horizontally define the impacted area. Upon receipt of analytical results from the site assessment activities a remediation work plan was drafted and subsequently approved by NMOCD on October 31, 2017.

GROUNDWATER AND SITE RANKING

According to the New Mexico Office of the State Engineer (NMOSE) groundwater in the project vicinity is approximately one hundred and eighty (180) feet below ground surface (BGS) (Appendix II). Therefore the site ranking for this release is zero (0) based on the following:

Depth to ground water >100-feet
 Distance to surface water body >1000-feet
 Wellhead Protection Area >1000-feet

- All of the excavated soil was hauled to an NMOCD approved solid waste disposal facility.
- The excavation was backfilled with locally obtained "like" soil and contoured to match the surrounding terrain.
