**1. Reason why this event was beyond Operator's control:**

This emissions event was caused by a third-party compressor station's facility planned maintenance activity, which is beyond Oxy's control to prevent or control from happening. Oxy was notified in the morning of June 04, 2023, by USA Compression, that a planned maintenance of their facility's equipment would be happening in the early afternoon and would affect the Lost Tank 13 Boo compressor station's ability to receive and process gas volumes, which in turn affects Oxy's upstream facility and its ability to send its gas to them. Lost Tank Boo 13 compressor station is the first stopping point, where OXY sends its sales gas from its facility, before it is pushed further down the pipeline for further processing at Mark West, a downstream gathering system facility, which is downstream of Oxy's control.

**2. Steps Taken to limit duration and magnitude of venting or flaring:**

The steps taken to limit the duration and magnitude of flaring during USA Compression's maintenance period was to shut in as much of production/wells as much as possible prior to USA Compression shutting down their equipment. Oxy did not anticipate the remaining wells not shut in to surge excessively all of sudden which in turn, overwhelmed the Lost Tank 18's operational processing abilities, which triggered several instances of intermittent flaring to occur. The Oxy production tech, on-site, then contacted Oxy's flowback personnel to begin making additional reduction choke changes to several high GOR wells, so that field pressure would stay below the flare trigger setpoints of the Lost Tank 18 CPF to cease flaring. This event is out of OXY's control, yet OXY made every effort to control and minimize emissions as much as possible.

**3. Corrective Actions taken to eliminate the cause and reoccurrence of venting or flaring:**

Oxy is unable to take any corrective actions to eliminate this cause and potential reoccurrence of this type of flaring as this was caused by a third-party compressor station's facility planned maintenance activity, which is beyond Oxy's control to prevent or control from happening. While this event was out of Oxy's control to avoid or prevent from happening, Oxy made every effort to minimize emissions while USA Compression was performing maintenance to its equipment. The only actions that Oxy can take and handle that is within its control, is to continually communicate with USA Compression personnel, who operate the Lost Tank Boo 13 Compressor Station, when possible, during these types of circumstances.
