Called Western Midstream control center to inquire about shut-in of meter run and was told at some point oxygen sensor hit limit and automatically shut-in the meter diverting gas to flare. Control center operator opened meter run and sensor readings remained normal. Gas flow went direct to sales and flare stopped.
