Initial investigation indicates that a concrete desalter containment berm had overflowed with rainwater and carried some diesel with rainwater to the ground immediately south of Eagle Draw containment. Upon further investigation it was noticed that a small amount of diesel/water mixture flowed over the containment berm into Eagle Draw, resulting in a ribbon of sheen on the water in Eagle Draw. All area with sheen remained within HF Sinclair Navajo Refining property boundary. Booms were immediately deployed to prevent further migration of sheen and an onsite vacuum truck was dispatched to remove all diesel impacted water. < 1 bbl of diesel impacted water was recovered, this action removed all sheen from the draw. Soil within the draw impacted by the release was also immediately cleaned up.
