Remediation Plan

Background:

On 3/8/2023 a release occurred due a 6-inch cemented line corroded. The release (GPS: 32.50402, -103.14070) is located north of Eunice, New Mexico in unit letter M section 2 township 17S range 37E. Depth to groundwater was determined by a measurement obtained in 2021 of a nearby monitor well. The depth of water was gauged at 63.68 feet.

Discrete vertical and horizontal grab samples were collected to delineate the release on 4/24 and 4/25/2023. All samples collected were submitted to a commercial laboratory for analysis for Cl-, TPH, and BTEX. All samples except SP8 were below table one standards for releases 51-100 feet to groundwater. Due to excessive chloride reading in respects to all other samples in the profile SP8 was resampled at the surface and 1 foot. Both samples were submitted to a commercial laboratory for analysis of chloride. The resample results were below table one standards for chloride.

Remediation Plan:

Apache Corporation proposes that the release area in the pasture be excavated in accordance with reclamation standards from 19.15.29 NMAC. Final 5-point bottom and wall composite samples will be collected not exceeding 400 square feet. Final 5-point surface composite samples will be collected on the pad and lease road not to exceed 400 square feet to confirm the entire release area not being reclaimed meet table one standards for releases 51-100 feet to groundwater. 5-point surface horizontal samples will be taken not to exceed 200 square feet to confirm the release on the lease pad and road did not enter the pasture. All samples collected will be submitted to a commercial laboratory for analysis of chloride, TPH, and BTEX. All excavated material (6000 yards) will be hauled to an OCD approved disposal facility. Once analytical confirm the release area is below table one closure standards for release 51-100 feet to groundwater and reclamation standards are meet in the top four feet of the pasture area the excavations in the pasture will be backfilled with clean imported topsoil and if excavation is required on the lease pad or lease road the pad will be restored with clean imported caliche. The pasture area will be reseed in accordance with the revegetation and noxious weed plan. The remediation will be completed within 90 days of OCD approval of the plan.
