The discharge line from the charge pump to the sending pump came apart at the KC Nipple releasing fluid to the lined secondary containment. The leak was isolated for repair. Approx. 150 bbls. of fluid was released and recovered.

Volume was verified with vac truck removal into an isolated tank and gauged.
