Steps taken to limit the duration and magnitude of vent or flare	Continued flaring to purge O2 out of our pipelines. Once gas was back in spec we stopped flaring. All of the facilities and emissions control devices at this site are operating as designed and, where applicable, are authorized. Chevron field personnel will execute practicable measures to minimize emissions.
